agreements with each of the college units. The student body grew 20.76% with 27,171 graduates through the fiscal year. The department included 26 team members with a budget of \$2.7M. I became a council member for ACBSP's legislative committee, and I pushed for national recognition of an 80-credit baccalaureate degree.

- In FY17, we obtained decennial reaffirmation of regional accreditation, joined the State Authorization Reciprocity Agreement, implemented a new strategy for monitoring and maintaining national compliance in highly regulated fields, added four new degree programs, and achieved a 18.79% growth rate in the student body while managing a team of 17 and a budget of \$2.1M.
