



# THE STATE OF GEORGIA

## EXECUTIVE ORDER

---

BY THE GOVERNOR:

**WHEREAS:** The State of Georgia may be subjected to emergencies and disasters of all kinds and of different magnitudes; and

**WHEREAS:** The State of Georgia will plan and prepare to guide state and local disaster recovery and redevelopment actions through the development of a plan to rebuild more safe, vibrant, sustainable and disaster resilient communities; and

**WHEREAS:** The GEMA/Homeland Security and the Georgia Department of Natural Resources Coastal Resources Division shall be responsible for writing the Georgia Disaster Recovery and Redevelopment Plan (GDRRP); and

**WHEREAS:** The State of Georgia will coordinate recovery and redevelopment actions in a manner consistent with the Georgia Disaster Recovery and Redevelopment Plan and the National Disaster Recovery Framework working through state agencies, local jurisdictions, volunteer organizations, and public and private agencies that have experience in recovery and redevelopment; and

**WHEREAS:** At the time of the activation of the Georgia Disaster Recovery and Redevelopment Plan, the Governor shall designate a state agency to coordinate and guide the disaster recovery and redevelopment efforts of the State; and

**WHEREAS:** The Georgia Disaster Recovery and Redevelopment Plan (GDRRP) shall identify recovery and redevelopment responsibilities that are consistent with the Georgia Emergency Operations Plan (GEOP) which identifies responsibilities to assist all local governments and citizens in the preparation for and response to emergencies and disasters.

**NOW, THEREFORE, BY THE AUTHORITY VESTED IN ME AS GOVERNOR OF THE STATE OF GEORGIA, IT IS HEREBY**

**ORDERED:** That the Georgia Recovery and Redevelopment Plan identifies Recovery Support Functions which serve as the basis to assist all state, local governments and citizens during pre and post disaster recovery and redevelopment activities.

**IT IS FURTHER**

**ORDERED:** That the coordinating agencies for the disaster recovery and redevelopment plan are as follows:

***Recovery Support Function 1-Disaster Recovery and Redevelopment Assistance Coordination and Planning***

Coordinator: Georgia Emergency Management Agency / Homeland Security

***Recovery Support Function 2-Economic Development***

Coordinator: Georgia Department of Economic Development

***Recovery Support Function 3-Health and Social Services***

Coordinator: Georgia Department of Public Health  
Georgia Department of Human Services

***Recovery Support Function 4-Community Development, Planning and Housing***

Coordinator: Georgia Department of Community Affairs

***Recovery Support Function 5-Infrastructure Systems***

Co-Coordinator: Environmental Protection Division, Georgia Department of Natural Resources

Co-Coordinator: Georgia Department of Transportation

***Recovery Support Function 6-Natural and Cultural Resources***

Coordinator: Georgia Department of Natural Resources

***Recovery Support Function 7-Volunteer Organizations Active in Disasters***

Coordinator: Georgia Emergency Management Agency / Homeland Security

Support Organization: Georgia Volunteer Organizations Active in Disasters

**IT IS FURTHER**

**ORDERED:** That each Recovery Support Function coordination agency shall appoint a Recovery Coordinator and Alternate to serve in the recovery phase after a natural or manmade disaster has occurred and as a planning liaison to the GEMA/Homeland Security.

**IT IS FURTHER**

**ORDERED:** That each state agency with Recovery Support Function assigned coordination, or support responsibilities shall provide assistance in

preparation and revision of such functions, collaborate with primary and support agencies and maintain associated Standard Operating Guides and other planning documents.

**IT IS FURTHER**

**ORDERED:** That each Recovery Support Function with coordinator responsibilities shall assign personnel to serve in the State Operations Center (SOC), Joint Field Office and or other state command and control facilities as necessary to support recovery operations, participate in training and exercises, prepare updates to the Georgia Disaster Recovery and Redevelopment Plan as necessary and maintain reporting systems as required by state and federal laws and regulations.

**IT IS FURTHER**

**ORDERED:** That each Recovery Support Function with coordinator responsibilities shall participate in all after action review discussions following activations of the Georgia Disaster Recovery and Redevelopment Plan to identify and complete necessary improvement actions.

**IT IS FURTHER**

**ORDERED:** That all other State Boards, Departments, Agencies, Associations, Institutions and Authorities not assigned a coordinator role in this plan will carry out whatever duties or services that may be required in a support role during an emergency or disaster as specified or directed by the Governor or the Director of the GEMA/Homeland Security.


**IT IS FURTHER**
