

House Bill 188 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act creating a board of commissioners for Lanier County, approved March 7,  
2 1933 (Ga. L. 1933, p. 602), as amended, particularly by an Act approved February 27, 2012  
3 (Ga. L. 2012, p. 3768), so as to revise the districts for the election of members of the board  
4 of commissioners; to provide for definitions and inclusions; to provide for the manner of  
5 election; to provide for the continuation in office of current members; to provide for related  
6 matters; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act creating a board of commissioners for Lanier County, approved March 7, 1933  
10 (Ga. L. 1933, p. 602), as amended, particularly by an Act approved February 27, 2012  
11 (Ga. L. 2012, p. 3768), is amended by striking Section 1 in its entirety and inserting in lieu  
12 thereof a new Section 1 to read as follows:

13 "SECTION 1.

14 (a) The Board of Commissioners of Lanier County shall be composed of five members.  
15 Except for the chairperson, the members of the board shall be residents of the  
16 commissioner districts they represent and shall be elected by the qualified electors voting  
17 within their respective commissioner districts. The chairperson shall be a resident of  
18 Lanier County and shall be elected by the qualified voters of the entire county.

19 (b) For the purpose of electing four members of the board from commissioner districts,  
20 Lanier County shall be divided into four commissioner districts. One member of the board  
21 shall be elected from each such district. Those districts shall be and correspond to those  
22 four numbered districts described in and attached to and made a part of this Act and further  
23 identified as 'Plan: lanierccsb-2015 Plan Type: Local Administrator: Lanier User: Gina'.

24 (c)(1) For the purposes of such plan:

25 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
 26 provided in the report of the Bureau of the Census for the United States decennial  
 27 census of 2010 for the State of Georgia. The separate numeric designations in a district  
 28 description which are underneath a 'VTD' heading shall mean and describe individual  
 29 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
 30 United States decennial census of 2010 for the State of Georgia; and

31 (B) Except as otherwise provided in the description of any district, whenever the  
 32 description of any district refers to a named city, it shall mean the geographical  
 33 boundaries of that city as shown on the census maps for the United States decennial  
 34 census of 2010 for the State of Georgia.

35 (2) Any part of Lanier County which is not included in any district described in  
 36 subsection (b) of this section shall be included within that district contiguous to such part  
 37 which contains the least population according to the United States decennial census of  
 38 2010 for the State of Georgia.

39 (3) Any part of Lanier County which is described in subsection (b) of this section as  
 40 being included in a particular district shall nevertheless not be included within such  
 41 district if such part is not contiguous to such district. Such noncontiguous part shall  
 42 instead be included within that district contiguous to such part which contains the least  
 43 population according to the United States decennial census of 2010 for the State of  
 44 Georgia."

45 **SECTION 2.**

46 Said Act is further amended by striking Section 3 in its entirety and inserting in lieu thereof  
 47 a new Section 3 to read as follows:

48 "SECTION 3.

49 (a) In the event that any member elected from a district ceases to be a resident of his or her  
 50 respective commissioner district during his or her term of office, a vacancy shall be created  
 51 and shall be filled in the manner provided in Section 18 of this Act. In all elections  
 52 conducted pursuant to this Act, each candidate shall designate, at the time of qualifying,  
 53 the district or chairperson post for which he or she offers as a candidate. All members shall  
 54 be nominated and elected in accordance with the provisions of Chapter 2 of Title 21 of the  
 55 O.C.G.A., the 'Georgia Election Code,' as now or hereafter amended.

56 (b) The members of the board who were elected at the general election in  
 57 November, 2012, shall continue in office for the terms to which they were elected and until  
 58 successors are elected and qualified as provided in this section. The members of the board  
 59 who were elected at the general election in November, 2014, shall continue in office for

60 the terms to which they were elected and until successors are elected and qualified as  
61 provided in this section.

62 (c) The first members of the reconstituted Board of Commissioners of Lanier County from  
63 Commissioner Districts 1 and 2 shall be elected in the state-wide general election in  
64 November, 2018. Such members shall take office on January 1 following their election for  
65 terms of four years and until their successors are elected and qualified.

66 (d) The first members of the reconstituted Board of Commissioners of Lanier County from  
67 Commissioner Districts 3 and 4 shall be elected in the state-wide general election in  
68 November, 2016. Such members shall take office on January 1 following their election for  
69 a term of four years and until their successors are elected and qualified.

70 (e) The first chairperson of the reconstituted Board of Commissioners of Lanier County  
71 shall be elected by all of the qualified voters of Lanier County voting in the state-wide  
72 general election in November, 2016. Such chairperson shall take office on January 1  
73 following his or her election for a term of four years and until his or her successor is  
74 elected and qualified.

75 (f) Successors to members elected under subsections (c), (d), and (e) of this section shall  
76 be elected at the state-wide general election next preceding the expiration of such terms of  
77 office and shall take office on January 1 following their election for terms of four years and  
78 until their successors are elected and qualified.

79 (g) Commissioner Districts 1, 2, 3, and 4 as they exist immediately prior to the effective  
80 date of this Act shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,  
81 respectively, but as newly described under this Act, and, on and after the effective date of  
82 this Act, such members of the board serving from those former commissioner districts shall  
83 be deemed to be serving from and representing their respective districts as newly described  
84 under this section."

85 **SECTION 3.**

86 All laws and parts of laws in conflict with this Act are repealed.
