

House Bill 999 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act to create a new charter for the City of Dacula, approved February 21, 1978  
2 (Ga. L. 1978, p. 3040), as amended, so as to change the corporate boundaries of the city; to  
3 provide for related matters; to provide an effective date; to repeal conflicting laws; and for  
4 other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 SECTION 1.

7 An Act to create a new charter for the City of Dacula, approved February 21, 1978  
8 (Ga. L. 1978, p. 3040), as amended, is amended by designating the existing text of  
9 subsection (a) of Section 1.11 as paragraph (1) and adding a new paragraph to read as  
10 follows:

11 "(2) In addition to the territory described in paragraph (1) of this subsection, the  
12 corporate boundaries of the city shall include all properties added through amendments  
13 to this charter; all properties added by all annexation ordinances adopted by the Mayor  
14 and Council of the City of Dacula since February, 1978; and the additional property  
15 described in this paragraph. These boundaries are shown on a map entitled the Official  
16 Map of the Corporate Limits of the City of Dacula, Georgia, last amendment dated  
17 April 15, 2013, which map is maintained in the office of the City Administrator of the  
18 City of Dacula, Georgia, and is incorporated herein by reference. The properties  
19 described herein and shown on the map are intended to include and are hereby declared  
20 to include all of the property included in the tax parcels set forth below as those tax  
21 parcels existed on the tax rolls and tax maps of Gwinnett County for the year 2014, and  
22 all properties annexed by ordinances approved by the Mayor and Council of the City of  
23 Dacula since February of 1978, and all property included in the tax parcels set forth  
24 below as those tax parcels exist on the tax rolls and tax maps of Gwinnett County for the  
25 year 2014, and all of the public roadways and rights of way adjacent to those parcels,

26 including railroad rights of way lying adjacent to those parcels or to the public roadways

37 **SECTION 2.**

38 This Act shall become effective upon its approval by the Governor or upon its becoming law  
 39 without such approval or on June 1, 2014, whichever is later.

40 **SECTION 3.**

41 All laws and parts of laws in conflict with this Act are repealed.
