A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act providing a new charter for the City of Manchester, approved August 16,
- 2 1909 (Ga. L. 1909, p. 1071), as amended, particularly by an Act approved August 20, 1923
- 3 (Ga. L. 1923, p. 739), an Act approved March 28, 1990 (Ga. L. 1990, p. 4980), and an Act
- 4 approved April 10, 2014 (Ga. L. 2014, p. 3692), so as to change provisions relating to the
- 5 filling of vacancies in the offices of members of the governing authority; to provide for
- 6 related matters; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act providing a new charter for the City of Manchester, approved August 16, 1909 (Ga.
- 10 L. 1909, p. 1071), as amended, particularly by an Act approved August 20, 1923 (Ga. L.
- 11 1923, p. 739), an Act approved March 28, 1990 (Ga. L. 1990, p. 4980), and an Act approved
- 12 April 10, 2014 (Ga. L. 2014, p. 3692), is amended by revising subsection (b) of Section 4 as
- 13 follows:
- 14 "(b) In the event that a member moves his or her residence from the district the member
- represents, that position on the city council shall immediately become vacant. Vacancies
- on the council created by death, resignation, or otherwise shall be filled in accordance with
- 17 Section 16 of the City Charter."

18 SECTION 2.

- 19 Said Act is further amended by deleting from Section 16 the following:
- 20 "In the case of vacancies in the office of any commissioner, or if he can not act, the
- 21 chairman shall immediately call a special election to fill said vacancy or vacancies after
- 22 giving ten days' notice either by publication or posting the same. Said special election shall
- be held under the same rules and regulations as general elections are now held in and for
- said city."
- and inserting in lieu thereof the following:

26 "Unless otherwise provided for by O.C.G.A. § 36-30-13, a vacancy in the office of the 27 mayor or any member of the city council shall be filled for the remainder of the unexpired 28 term, if any, as follows: (1) if the vacancy occurs and there are more than 18 months remaining in the term of office of the seat vacated, then such vacancy shall be filled for the 29 30 unexpired term of office at a special election held in accordance with Georgia law; (2) if the vacancy occurs and there are 18 or fewer months remaining in the term of office of the 31 32 seat vacated, then the remaining members of the city council shall, by majority vote of 33 those present and voting, select a qualified person to serve the remainder of the unexpired 34 term."

35 SECTION 3.

36 All laws and parts of laws in conflict with this Act are repealed.
