A BILL TO BE ENTITLED AN ACT

- 1 To amend Chapter 4 of Title 26 of the Official Code of Georgia Annotated, relating to
- 2 pharmacists and pharmacies, so as to revise the definition of "practitioner"; to provide that
- 3 certain provisions of law regarding pharmacists and pharmacies shall not apply to a facility
- 4 engaged solely in the distribution of dialysate drugs, or devices necessary to perform home
- 5 kidney dialysis to patients with end stage renal disease, provided that certain criteria are met;
- 6 to authorize certain refills by pharmacists of topical ophthalmic products under certain
- 7 conditions; to provide for related matters; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 SECTION 1.

- 10 Chapter 4 of Title 26 of the Official Code of Georgia Annotated, relating to pharmacists and
- pharmacies, is amended by revising paragraph (33) of Code Section 26-4-5, relating to
- 12 definitions, as follows:

- 13 "(33) 'Practitioner' or 'practitioner of the healing arts' means a physician, dentist,
- podiatrist, optometrist, or veterinarian and shall include any other person licensed under
- the laws of this state to use, mix, prepare, dispense, prescribe, and administer drugs in
- 16 connection with medical treatment to the extent provided by the laws of this state."
- SECTION 2.
- 18 Said chapter is further amended by adding a new Code section to read as follows:
- 19 "<u>26-4-6.</u>
- 20 The provisions of this chapter shall not apply to a facility engaged solely in the distribution
- 21 <u>of dialysate drugs, or devices necessary to perform home kidney dialysis to patients with</u>
- 22 <u>end stage renal disease, provided that the following criteria are met:</u>
- 23 (1) The dialysate drugs, or devices are approved or cleared by the federal Food and Drug
- 24 <u>Administration as required by federal law;</u>

- 26 agent that is properly registered with the board as a manufacturer or wholesale
- 27 <u>distributor</u>;
- 28 (3) The dialysate drugs, or devices are held and delivered in their original, sealed
- 29 packaging from the manufacturing facility;
- 30 (4) The dialysate drugs, or devices are delivered only by the manufacturer or the
- 31 manufacturer's agent and only upon receipt of a physician's order; and
- 32 (5) The manufacturer or manufacturer's agent delivers the dialysate drugs, or devices
- 33 <u>directly to:</u>
- 34 (A) A patient with end stage renal disease or such patient's designee for the patient's
- 35 <u>self-administration of the dialysis therapy; or</u>
- 36 (B) A health care provider or institution for administration or delivery of the dialysis
- 37 therapy to a patient with end stage renal disease."

38 SECTION 3.

- 39 Said chapter is further amended by revising subsection (f) of Code Section 26-4-80, relating
- 40 to dispensing prescription drugs, as follows:
- 41 ''(f)(1) When filling a prescription or refilling a prescription which may be refilled, the
- 42 pharmacist shall exercise professional judgment in the matter. No prescription shall be
- filled or refilled with greater frequency than the approximate interval of time that the
- dosage regimen ordered by the <u>prescriber practitioner</u> would indicate, unless extenuating
- 45 circumstances are documented which would justify a shorter interval of time before the
- filling or refilling of the prescription.
- 47 (2) Notwithstanding paragraph (1) of this subsection, in order to prevent unintended
- interruptions in drug therapy for topical ophthalmic products:
- 49 (A) A pharmacist shall be authorized, without obtaining subsequent authorization from
- 50 <u>the practitioner or obtaining a new prescription from the practitioner, to permit refills</u>
- at 70 percent of the predicted days of use; and
- 52 (B) At the patient's request, a practitioner shall be permitted to authorize refills earlier
- 53 than 70 percent of the predicted days of use.
- 54 This paragraph shall apply to refills purchased through retail pharmacies and mail order
- 55 <u>sources.</u>"

SECTION 4.

57 All laws and parts of laws in conflict with this Act are repealed.
