

House Bill 1012 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act changing the compensation of the clerk of the superior court, the sheriff,  
2 and the judge of the Probate Court of Cobb County from the fee system to the salary system,  
3 approved February 9, 1949 (Ga. L. 1949, p. 427), as amended, particularly by an Act  
4 approved April 10, 2014 (Ga. L. 2014, p. 4104), an Act approved April 10, 2014 (Ga. L.  
5 2014, p. 4269), and an Act approved May 12, 2015 (Ga. L. 2015, p. 4284), so as to change  
6 the salary of the clerk of the superior court, the deputy clerk, the executive assistant, and the  
7 executive secretary; to provide for related matters; to repeal conflicting laws; and for other  
8 purposes.

9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

10 **SECTION 1.**

11 An Act changing the compensation of the clerk of the superior court, the sheriff, and the  
12 judge of the Probate Court of Cobb County from the fee system to the salary system,  
13 approved February 9, 1949 (Ga. L. 1949, p. 427), as amended, particularly by an Act  
14 approved April 10, 2014 (Ga. L. 2014, p. 4104), an Act approved April 10, 2014 (Ga. L.  
15 2014, p. 4269), and an Act approved May 12, 2015 (Ga. L. 2015, p. 4284), is amended by  
16 revising Section 4 as follows:

17 "SECTION 4.

18 (a) The clerk of the superior court shall receive an annual salary of \$131,947.88 to be paid  
19 in equal monthly installments from the funds in the county treasury.

20 (b) The clerk of the superior court shall be allowed a deputy clerk whose annual salary  
21 shall be \$104,290.29 to be paid in equal monthly installments from the funds in the county  
22 treasury. Any candidate for the office of clerk of the Superior Court of Cobb County shall,  
23 on the date of his or her qualification for such office in either a primary or general election,  
24 certify to the judge of the Probate Court of Cobb County the name of the person he or she  
25 shall appoint as deputy clerk in the event he or she is elected to the office of clerk; and the

26 person so named and certified by the successful candidate for such office shall serve as the  
27 deputy clerk during the term for which he or she was so named. In the event of the death  
28 or removal from office of said deputy clerk, the clerk of the superior court shall have 30  
29 days from said date of death or removal from office of said deputy clerk to certify to the  
30 judge of the Probate Court of Cobb County the name of the new deputy clerk to be  
31 appointed. In addition to said deputy clerk, the clerk of the Superior Court of Cobb County  
32 shall be authorized and empowered to employ the clerical help necessary to perform  
33 properly the functions and duties of the office, provided that the number of employees and  
34 salaries or other compensation to be paid to each shall first be approved by the governing  
35 authority of Cobb County.

36 (c) The clerk of the superior court shall be allowed an executive assistant and an executive  
37 secretary appointed by and under the direct supervision of the clerk of the superior court.  
38 The persons so appointed shall serve at the pleasure of the clerk. The clerk of the superior  
39 court shall establish the qualifications, education, and experience necessary for  
40 appointment to such positions. The salary of the executive assistant shall be \$64,200.92  
41 per annum, and the salary of the executive secretary shall be \$59,262.38 per annum, both  
42 paid in equal monthly installments from the funds of Cobb County."

43 **SECTION 2.**

44 All laws and parts of laws in conflict with this Act are repealed.
