EXECUTIVE ORDER

BY THE GOVERNOR:

WHEREAS: Hart County District 1 Commissioner R.C. Oglesby was indicted on February 18, 2020 on one count of Violation of Racketeer Influenced and Corrupt Organizations Act, ten counts of Theft by Shoplifting, one count of Financial Transaction Card Theft, and two counts of Financial Transaction Card Fraud; and

WHEREAS: The indictment was transmitted to the Governor pursuant to O.C.G.A. § 45-5-6(b), and the certified copy was received on July 6, 2020; and

WHEREAS: On August 20, 2020, I appointed Attorney General Christopher Carr, Commissioner Carvel Lewis of Georgetown-Quitman County, and Commissioner Doug Duncan of Columbia County as the Review Commission to determine whether the indictment relates to and adversely affects the administration of the office of Commissioner Oglesby such that the rights and interests of the public are adversely affected thereby, and to make a written report to me within fourteen days with a recommendation as to whether said commissioner should be suspended from office as required by O.C.G.A. § 45-5-6(e); and

WHEREAS: On September 14, 2020, pursuant to the request of the Review Commission, I extended the deadline for the Review Commission's report to September 24, 2020; and

WHEREAS: On September 24, 2020, the Review Commission issued its report finding that the indictment of R.C. Oglesby does relate to and does adversely affect the administration of the office of Commissioner, and that the rights and interests of the public are adversely affected thereby; and recommending that R.C. Oglesby be suspended from office pursuant to the provisions of O.C.G.A. § 45-5-6.


WHEREAS: On September 30, 2020, pursuant to the recommendation of the Review Commission, I issued Executive Order 09.30.30.08 suspending R.C. Oglesby from his office as Hart County District 1 Commissioner; and

WHEREAS: On October 1, 2020, R.C. Oglesby, through Counsel, petitioned me in writing for a review of his suspension as Hart County District 1 Commissioner under O.C.G.A. § 45-5-6(f).

NOW, THEREFORE, BY VIRTUE OF THE AUTHORITY VESTED IN ME AS GOVERNOR OF THE STATE OF GEORGIA, IT IS HEREBY

ORDERED: That pursuant to O.C.G.A. § 45-5-6(f), Attorney General Christopher Carr, Commissioner Carvel Lewis of Georgetown-Quitman County, and Commissioner Doug Duncan of Columbia County are hereby re-appointed as the Review Commission to review the suspension of R.C. Oglesby as Hart County District 1 Commissioner, and to make a written report within 14 days.
