BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 An Act to continue the existence of the Atlanta Independent School System under the
- 9 management and control of the Atlanta Board of Education, approved June 3, 2003
- 10 (Ga. L. 2003, p. 4154), as amended, particularly by an Act approved May 6, 2013 (Ga.
- 11 L. 2013, p. 4341), is amended by revising subsection (g) of Section 2-103 as follows:
- ''(g)(1) Successors to members of the board whose terms of office are to expire shall be
- elected at the time of the general municipal election immediately preceding the expiration
- of such terms and shall take office the first day of January immediately following that
- election. Members of the board shall serve for the terms of office specified therefor in
- this subsection and until their respective successors are elected and qualified.
- 17 (2) Those members of the board who are serving as such on the effective date of this Act
- shall continue to serve as such members for the terms of office to which they were
- elected. The members elected to Education Districts 1, 3, 5, 7, and 9 at the general
- 20 municipal election in 2021 shall each serve a term of two years ending on
- December 31, 2023. The members elected to Education Districts 2, 4, 6, and 8 at the
- general municipal election in 2021 shall each serve a term of four years ending on
- December 31, 2025. Thereafter all members of the board shall each serve a term of office
- of four years."

26 Said Act is further amended by revising subsection (a) of Section 2-104 as follows:

"(a) Organizational meeting; oath. At the first regular meeting of the board in January following each regular election, the board shall organize, and members of the board elected at the preceding regular election shall take and subscribe before a judge of the Superior Court, the following each of office:

I do solemnly swear (or affirm) that I will faithfully and impartially discharge the duties of a member of the Atlanta Board of Education during my term in office. I will not knowingly permit my vote in the election and appointment of any person to a position in the Atlanta Independent School System, or on any matter related to said school system, to be influenced by fear, favor, affection, or reward, or hope thereof. In all things pertaining to my said office, I will be governed by the public good and the interests of said school system. I will observe the provisions of the Act reorganizing the Atlanta Board of Education and the rules and regulations of the Atlanta Board of Education. I further swear (or affirm) that I will support and defend the Constitutions and laws of the State of Georgia and of the United States of America."
