

House Bill 487 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend Article 6 of Chapter 3 of Title 38 of the Official Code of Georgia Annotated,
2 relating to the Disaster Volunteer Relief Act, so as to authorize certain employees of state
3 agencies to be granted leave from work with pay in order to participate in specialized disaster
4 relief services; to provide for a short title; to repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 style="text-align:center">**SECTION 1.**

7 This Act shall be known and may be cited as the "Robert Argo Disaster Volunteer Relief
8 Act."

9 style="text-align:center">**SECTION 2.**

10 Article 6 of Chapter 3 of Title 38 of the Official Code of Georgia Annotated, relating to the
11 Disaster Volunteer Relief Act, is amended by revising Code Section 38-3-93, relating to
12 authorizing certain employees of state agencies to be granted leave from work with pay in
13 order to participate in specialized disaster relief services, as follows:

14 "38-3-93.

15 (a) An employee of a state agency who is a certified disaster service volunteer of the
16 American Red Cross may be granted leave from his or her work with pay for ~~not to exceed~~
17 no more than 15 workdays in any 12 month period to participate in specialized disaster
18 relief services for the American Red Cross, upon the request of the American Red Cross
19 for the services of that employee and upon the approval of that employee's agency and
20 coordinated through the director of emergency management, without loss of seniority, pay,
21 vacation time, compensatory time, sick time, or earned overtime accumulation. The state
22 agency shall compensate an employee granted leave under this Code section at his or her
23 regular rate of pay for those regular hours during which the employee is absent from work.
24 Leave under this article shall be granted only for the services related to a disaster occurring
25 within this state or in a contiguous state which has a reciprocal statutory provision.

26 (b) An employee of a state agency who is a certified disaster service volunteer of the Civil
27 Air Patrol Auxiliary of the United States Air Force may be granted leave from his or her
28 work with pay for no more than 15 workdays in any 12 month period to participate in
29 specialized emergency services operations for the Civil Air Patrol Auxiliary of the United
30 States Air Force, upon the request of the Civil Air Patrol Auxiliary of the United States Air
31 Force after being activated by a county emergency management agency, the Georgia
32 Emergency Management and Homeland Security Agency, or a comparable federal agency
33 for the services of that employee and upon the approval of that employee's agency and
34 coordinated through the director of emergency management, without loss of seniority, pay,
35 vacation time, compensatory time, sick time, or earned overtime accumulation. This
36 provision applies only to service rendered on a numbered mission in support of a county
37 emergency management agency, the Georgia Emergency Management and Homeland
38 Security Agency, or a comparable federal agency. The state agency shall compensate an
39 employee granted leave under this Code section at his or her regular rate of pay for those
40 regular hours during which the employee is absent from work. Leave under this article
41 shall be granted only for the services related to a disaster occurring within this state or in
42 a contiguous state which has a reciprocal statutory provision."

SECTION 3.

44 All laws and parts of laws in conflict with this Act are repealed.
