A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 1 of Chapter 7 of Title 50 of the Official Code of Georgia Annotated,
- 2 relating to general provisions regarding the Department of Economic Development, so as to
- 3 provide for the Department of Natural Resources to construct, operate, maintain, and supply
- 4 informational materials at welcome centers assigned to it by the Governor; to provide for the
- 5 installation and operation of automated teller machines and cash-dispensing machines at
- 6 welcome centers; to provide for the installation, operation, and setting of product prices for
- 7 vending machines; to provide for related matters; to provide for an effective date; to repeal
- 8 conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- 11 Article 1 of Chapter 7 of Title 50 of the Official Code of Georgia Annotated, relating to
- 12 general provisions regarding the Department of Economic Development, is amended by
- 13 revising Code Section 50-7-12, relating to welcome centers authorized, department to
- 14 construct, operate, and maintain centers, installation and operation of vending machines,
- 15 automated teller machines, and cash-dispensing machines, as follows:
- 16 "50-7-12.

- 17 (a) The Governor shall have authority to direct and provide for the construction of
- welcome centers at or near the point of entrance into this state of any federal highway. The
- 19 Department of Transportation may exercise the power of eminent domain in acquiring fee
- simple title to suitable locations for the erection of such welcome centers. Any welcome
- 21 center acquired prior to April 23, 1969, may be maintained and improved, regardless of
- whether the fee simple title therefor is in the state.
- 23 (b) It shall be the duty of the Department of Economic Development or the Department
- 24 <u>of Natural Resources</u> to construct, operate, and maintain the welcome centers <u>assigned to</u>
- 25 <u>such agency by the Governor</u> and keep them supplied with such information, pamphlets,

and other materials as will advertise and publicize the tourist attractions, natural resources,
 industry, history, and commerce of this state.

(c) The Department of Economic Development or the Department of Natural Resources, with the concurrence of the Department of Transportation, is further authorized to install or provide for the installation of and to operate or provide for the operation of vending machines and to sell in such machines nonalcoholic beverages, snacks, candy, cigarettes, and other articles as determined by the Department of Economic Development or the Department of Natural Resources to be necessary or desirable for the traveling public at reasonable prices at the welcome centers assigned to such agency. The prices charged for these products will approximate the prevailing rate within the area for similar items so as not to compete unfairly with private enterprise, such prices to be set by the Department of Economic Development or the Department of Natural Resources for the welcome centers assigned to such agency. The Department of Economic Development or the Department of Natural Resources is also authorized to provide for the sale or free distribution of articles and merchandise at the welcome centers assigned to such agency in such manner as is deemed to be in the best interest of promoting the tourist trade in this state.

(d) The Department of Economic Development or the Department of Natural Resources, with the concurrence of the Department of Transportation, is authorized to provide for the installation and operation at welcome centers of automated teller machines and cash-dispensing machines at the welcome centers assigned to such agency. If so authorized, such machines shall be established, placed, and operated in accordance with applicable law. Such machines shall be placed in welcome centers upon such terms and conditions as shall be deemed by the Department of Economic Development or the Department of Natural Resources for the welcome centers assigned to such agency to be in the best interest of the state and the traveling public."

- (a) The Governor shall have authority to direct and provide for the construction of a tourist
- center on real property owned by or which may be acquired by the state within the general
- vicinity or area of the domestic residence of any citizen of this state when such citizen has
- been elected President of the United States and the Governor determines that the number
- of tourists and other persons visiting the area justifies the center.
- 60 (b) It shall be the duty of the Department of Economic Development or the Department
- of Natural Resources to construct, operate, and maintain the any such tourist center

62 assigned to such agency by the Governor and keep it supplied with such information, 63 pamphlets, and other materials as will advertise and publicize the tourist attractions, natural 64 resources, industry, history, and commerce of this state. 65 (c) The Department of Economic Development or the Department of Natural Resources is further authorized to provide space for other commercial or noncommercial projects in 66 67 the center <u>assigned to such agency</u> and allow the persons to sell or provide such articles or 68 services as may be prescribed in the lease, contract, franchise, or other arrangement, as 69 determined by the department Department of Economic Development or the Department 70 of Natural Resources for the center assigned to such agency. The Department of Economic Development or the Department of Natural Resources shall regulate the sale or free 71 72 distribution of such articles, merchandise, and services by other persons at the center 73 assigned to such agency in the manner it deems to be in the best interest of promoting tourist trade in this state and otherwise furthering the purposes for which the center is 74 75 created. The Department of Economic Development or the Department of Natural 76 Resources is further authorized to install or provide for the installation of and to operate 77 or provide for the operation of vending machines and to sell in such machines nonalcoholic 78 beverages, snacks, candy, cigarettes, and other articles as determined by the Department 79 of Economic Development or the Department of Natural Resources to be necessary or 80 desirable for the traveling public at reasonable prices at the center assigned to such agency. 81 The prices charged for these products will approximate the prevailing rate within the area 82 for similar items so as not to compete unfairly with private enterprise, such prices to be set by the department <u>Department of Economic Development or the Department of Natural</u> 83 84 Resources for the center assigned to such agency. (d) The Department of Economic Development or the Department of Natural Resources 85 86 may also enter into contracts with other state, local, or federal agencies or with other 87

(d) The Department of Economic Development or the Department of Natural Resources may also enter into contracts with other state, local, or federal agencies or with other persons to assist it in construction, operation, or maintenance of the center <u>assigned to such agency</u>. The <u>department Department of Economic Development or the Department of Natural Resources</u> may acquire real and personal property for such purposes <u>for the center assigned to such agency</u>."
