## A BILL TO BE ENTITLED AN ACT

- 1 To abolish the Glynn County Police Department; to provide for the transfer of assets and
- 2 property of such police department; to provide for the transfer of duties and responsibilities
- 3 of such police department; to provide for related matters; to provide for a referendum,
- 4 effective dates, contingencies, and automatic repeal; to repeal conflicting laws; and for other
- 5 purposes.

## 6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 (a) The Glynn County Police Department is abolished on May 2, 2021.
- 9 (b) On and after such date, all property, equipment, records, documents, funds, and other
- 10 items in the possession or control of the county police department shall be transferred to the
- 11 Sheriff of Glynn County.
- 12 (c) On and after such date, the duties and responsibilities of the Glynn County Police
- 13 Department shall be assumed by the Sheriff of Glynn County.

14 SECTION 2.

- 15 The election superintendent of Glynn County shall call and conduct an election as provided
- 16 in this section for the purpose of submitting this Act to the electors of Glynn County for
- 17 approval or rejection. The election superintendent shall conduct that election on the Tuesday
- 18 next following the first Monday in November, 2020, and shall issue the call and conduct that
- 19 election as provided by general law. The superintendent shall cause the date and purpose of
- 20 the election to be published once a week for two weeks immediately preceding the date
- 21 thereof in the official organ of Glynn County. If an Act is approved in the 2020 session of
- 22 the General Assembly to place a nonbinding referendum regarding whether to abolish or
- 23 retain the Glynn County Police Department on the ballot, the binding referendum question
- 24 contained in this Act shall be placed immediately following such nonbinding referendum
- 25 question on the ballot. The ballot shall have written or printed thereon the words:

## 26 "BINDING REFERENDUM

- 27 ( ) YES Shall the Act be approved that abolishes the Glynn County Police 28 ( ) NO Department and transfers the functions and assets of such department to the
- 29 Sheriff of Glynn County?"
- 30 All persons desiring to vote for approval of the Act shall vote "Yes," and those persons
- 31 desiring to vote for rejection of the Act shall vote "No." If more than one-half of the votes
- 32 cast on such question are for approval of the Act and a general law is enacted by the 2020
- 33 regular session of the General Assembly authorizing the abolition of county police
- departments by local Act of the General Assembly, then Section 1 of this Act shall become
- of full force and effect on January 1, 2021. If the Act is not so approved, if the referendum
- 36 provided for in this section is not held, or if a general law authorizing the abolition of county
- 37 police departments by local Act of the General Assembly is not enacted as provided in this
- 38 section, then Section 1 of this Act shall not become effective and this Act shall be
- 39 automatically repealed on the first day of January immediately following such election date.
- 40 The expense of such election shall be borne by Glynn County. It shall be the election
- 41 superintendent's duty to certify the result thereof to the Secretary of State.
- 42 SECTION 3.
- 43 Except as otherwise provided in Section 2 of this Act, this Act shall become effective upon
- 44 its approval by the Governor or upon its becoming law without such approval.
- 45 SECTION 4.
- 46 All laws and parts of laws in conflict with this Act are repealed.
