A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 7 of Chapter 4 of Title 49 of the Official Code of Georgia Annotated,
- 2 relating to medical assistance generally, so as to direct the Department of Community Health
- 3 to submit a state plan amendment to implement express lane eligibility in Medicaid and the
- 4 PeachCare for Kids Program; to direct the Department of Human Services to automatically
- 5 enroll and renew eligible children in Medicaid and the PeachCare for Kids Program, based
- 6 on application data received for the Supplemental Nutrition Assistance Program; to provide
- 7 for related matters; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 SECTION 1.

- 10 Article 7 of Chapter 4 of Title 49 of the Official Code of Georgia Annotated, relating to
- medical assistance generally, is amended by adding a new Code section to read as follows:

- 13 (a) No later than June 30, 2022, the department shall submit a state plan amendment to the
- 14 <u>federal Department of Health and Human Services to implement express lane eligibility in</u>
- accordance with section 1902(e)(13) of the federal Social Security Act to determine
- whether a child meets one or more of the eligibility criteria for and enroll the child in

17	Medicaid and the PeachCare for Kids Program. Such state plan amendment shall include,
18	but not be limited to, reliance on a finding made by the Division of Family and Children
19	Services of the Department of Human Services in determining eligibility of applicants for
20	the federal Supplemental Nutrition Assistance Program and other programs as identified
21	by the department and the Division of Family and Children Services of the Department of
22	Human Services.
23	(b) Upon approval of a state plan amendment, the Division of Family and Children
24	Services of the Department of Human Services shall employ express lane eligibility by
25	evaluating data received from applicants for the federal Supplemental Nutrition Assistance
26	Program and other programs, as identified by the department and the Division of Family
27	and Children Services of the Department of Human Services, to determine eligibility for
28	Medicaid and the PeachCare for Kids Program and to provide for automatic enrollment and
29	renewal of eligible children in Medicaid and the PeachCare for Kids Program."

31 All laws and parts of laws in conflict with this Act are repealed.
