A BILL TO BE ENTITLED AN ACT

1 To amend Article 2 of Chapter 10 of Title 2 of the Official Code of Georgia Annotated, 2 relating to farmers' markets, so as to provide for oversight by a legislative advisory 3 committee; to provide for members, duties, and allowances; to provide for presentation of 4 findings; to provide for planning; to provide for automatic repeal; to provide for related 5 matters; to provide for an effective date; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7	SECTION 1.
8	Article 2 of Chapter 10 of Title 2 of the Official Code of Georgia Annotated, relating to
9	farmers' markets, is amended by adding a new Code section to read as follows:
10	″ <u>2-10-53.1.</u>
11	(a) The Commissioner shall establish, operate, and maintain this state's farmers' markets
12	under the oversight of a legislative advisory committee to be composed as follows:
13	(1) The chairpersons of the House Appropriations Subcommittee for Economic
14	Development and Tourism and the Senate Appropriations Subcommittee for Agriculture
15	and Consumer Affairs or their designees, ex officio;

16	(2) The chairperson of the House Agriculture and Consumer Affairs Committee or his		
17	or her designee;		
18	(3) The chairperson of the Senate Agriculture and Consumer Affairs Committee or his		
19	or her designee;		
20	(4) Three members of the House of Representatives appointed by the chairperson of the		
21	House Agriculture and Consumer Affairs Committee; and		
22	(5) Three members of the Senate appointed by the chairperson of the Senate Agriculture		
23	and Consumer Affairs Committee.		
24	(b) The members of the legislative advisory committee shall appoint the committee's		
25	chairperson and vice-chairperson, who shall each serve two-year terms to coincide with the		
26	legislative biennium of the General Assembly.		
27	(c) The members of the legislative advisory committee shall receive the allowances		
28	provided for in Code Section 28-1-8.		
29	(d) The legislative advisory committee created by this Code section shall be tasked with		
30	the duty to:		
31	(1) Commission an independent study of the economic viability and public benefit of		
32	each existing farmers' market with an analysis of the benefits to this state's agribusiness		
33	economy, including this state's farmers, food supply chain, grocers, restaurants,		
34	agri-tourism, local economies, and the effectiveness of the marketing of Georgia grown		
35	products. Upon completion of the study, the findings shall be presented to the legislative		
36	advisory committee; and		
37	(2) Using such findings as provided for in paragraph (1) of this subsection, coordinate		
38	with the Commissioner and the department to develop a five-year plan for all of this		
39	state's farmers' markets that maximizes the public benefit of all farmers' market properties		
40	and ensures efficient and fiscally responsible operation of such markets.		
41	(e) This Code section shall stand repealed on January 10, 2027."
