# A BILL TO BE ENTITLED AN ACT

1 To amend Article 1 of Chapter 10 of Title 13 of the Official Code of Georgia Annotated,
2 relating to general provisions regarding contracts for public works, Code Section 32-2-70 of
3 the Official Code of Georgia Annotated, relating to bonds of successful bidder, and Part 1
4 of Article 3 of Chapter 91 of Title 36 of the Official Code of Georgia Annotated, relating to
5 bonds generally, so as to provide for acceptance of electronic signatures and electronic
6 corporate seals on bonds; to provide for related matters; to provide an effective date; to
7 repeal conflicting laws; and for other purposes.

#### **SECTION 1-1.**

Article 1 of Chapter 10 of Title 13 of the Official Code of Georgia Annotated, relating to
general provisions regarding contracts for public works, is amended by adding a new Code
section to read as follows:

## **SECTION 2-1.**

26 Code Section 32-2-70 of the Official Code of Georgia Annotated, relating to bonds of 27 successful bidder, is amended as follows:

29 (a) Where the contract price exceeds \$100,000.00, no department construction contract

30 shall be valid unless the contractor first gives:

31 (1) The performance and payment bonds in accordance with Chapter 10 of Title 13; and

32 (2) Such other bonds or insurance policies required by the department in its proposal

- 33 forms, including but not limited to public liability and property damage insurance bonds
- 34 or policies.
- 35 (b) Public procurement officers shall accept electronic signatures and electronic corporate
- 36 seals on bonds issued pursuant to this Code section so long as such signatures and seals
- 37 comply with the provisions of Chapter 12 of Title 10 and Code Section 33-24-14."
