



# THE STATE OF GEORGIA

## EXECUTIVE ORDER

BY THE GOVERNOR:

**WHEREAS:** The State of Georgia holds title to approximately 3,572 acres of real property ("Property") as shown on the survey attached hereto as Exhibit "A", which Property is a portion of the Southwestern State Hospital; and

**WHEREAS:** Said Property is a portion of approximately 207.852 acres of improved State property lying and being in Land Lots 5, 6, 41, and 42, 13<sup>th</sup> Land District, Thomas County, Georgia, acquired by virtue of a Quitclaim Deed recorded in Deed Book 27, Pages 625-645, and Release of Conditions Subsequent, recorded in Deed Book 1954, pages 362-367, in the office of the Clerk of Superior Court of Thomas County, and filed with the State Properties Commission Real Property Records as RPR# 03432, and RPR # 003432.01 respectively; and

**WHEREAS:** By Resolution dated August 18, 2016, the Georgia Department of Behavioral Health and Developmental Disabilities declared the Property surplus to the needs of the Department; and

**WHEREAS:** Said Property is adjacent to 1.92 acres of property under the custody of the Georgia Bureau of Investigation and used as the Investigative Division Regional Office; and

**WHEREAS:** By Resolution dated April 14, 2022, the Board of Public Safety requested the transfer of custody of the Property to the Georgia Bureau of Investigation for the purposes of expanding the current Investigative Division Regional Office.

**NOW, THEREFORE, PURSUANT TO THE AUTHORITY VESTED IN ME AS GOVERNOR OF THE STATE OF GEORGIA, IT IS HEREBY**

**ORDERED:** That custody of the above-defined Property located in Thomas County, Georgia is hereby transferred from the Georgia Department of Behavioral Health and Developmental Disabilities to the Georgia Bureau of Investigation.

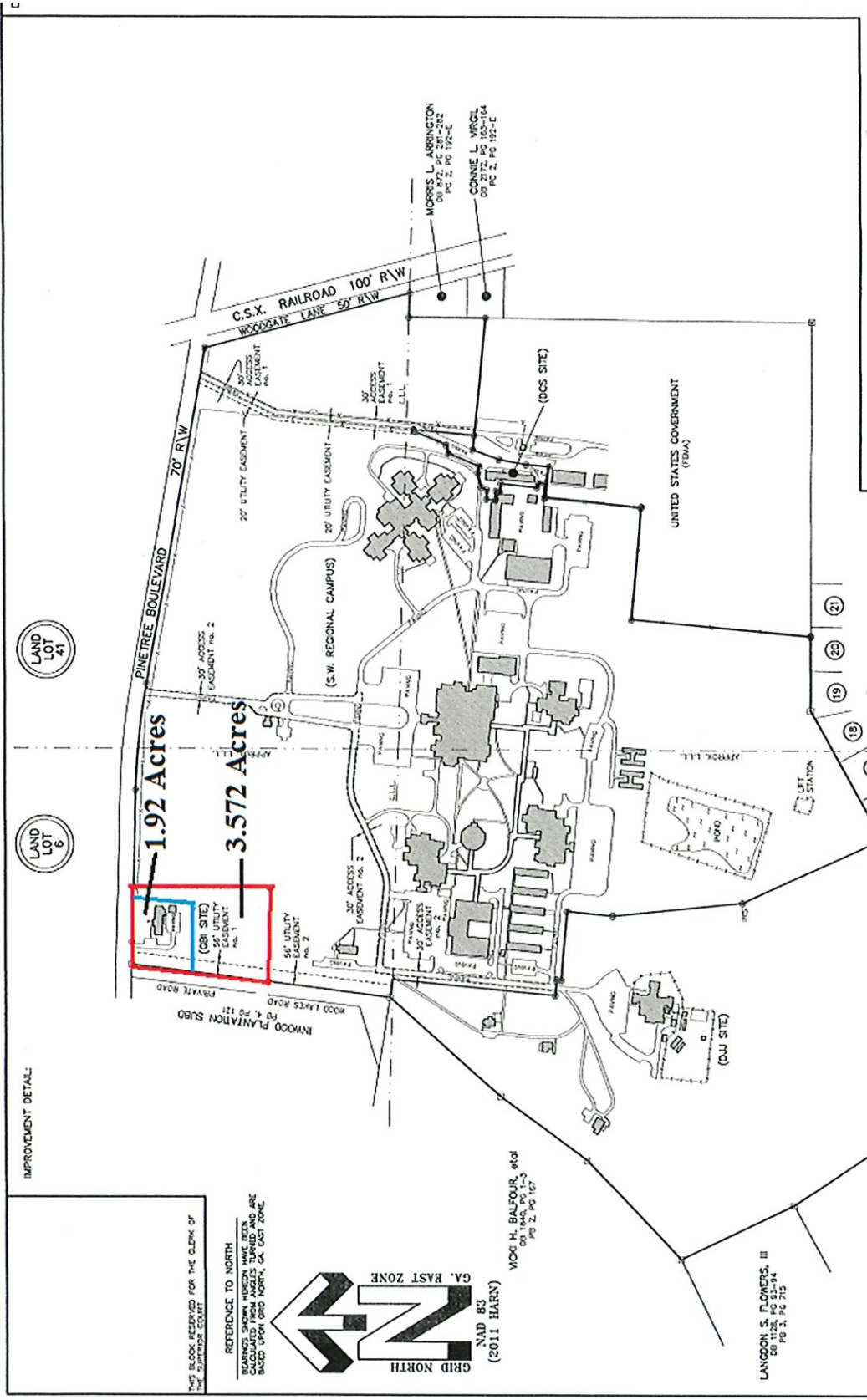
