

House Bill 1020 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act creating the Board of Commissioners of Glynn County, approved  
2 February 11, 1937 (Ga. L. 1937, p. 1336), as amended, particularly by an Act approved  
3 February 27, 2012 (Ga. L. 2012, p. 3627), so as to provide new district boundaries; to  
4 provide for definitions and inclusions; to provide for continuation in office of the current  
5 members; to provide for related matters; to provide for effective dates; to repeal conflicting  
6 laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act creating the Board of Commissioners of Glynn County, approved February 11, 1937  
10 (Ga. L. 1937, p. 1336), as amended, particularly by an Act approved February 27, 2012 (Ga.  
11 L. 2012, p. 3627), is amended by revising subsections (a), (b), (e), and (h) of Section 1 as  
12 follows:

13 "(a) There is created the Board of Commissioners of Glynn County to be composed of  
14 seven members to be elected as hereafter provided. For the purpose of electing members  
15 of the board of commissioners, Glynn County shall be divided into five commissioner  
16 districts which shall be and correspond to those five numbered districts described in

17 Appendix A attached to and made a part of this Act and further identified as 'User: Glynn  
18 Plan Name: GlynnCCSB-2022 Plan Type: Local'.

19 (b)(1) For the purposes of such plan:

20 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
21 provided in the report of the Bureau of the Census for the United States decennial  
22 census of 2020 for the State of Georgia. The separate numeric designations in a district  
23 description which are underneath a VTD heading shall mean and describe individual  
24 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
25 United States decennial census of 2020 for the State of Georgia; and

26 (B) Except as otherwise provided in the description of any district, whenever the  
27 description of any district refers to a named city, it shall mean the geographical  
28 boundaries of that city as shown on the census maps for the United States decennial  
29 census of 2020 for the State of Georgia.

30 (2) Any part of Glynn County which is not included in any particular commissioner  
31 district described in subsection (a) of this section shall be included within that  
32 commissioner district contiguous to such part which contains the least population  
33 according to the United States decennial census of 2020 for the State of Georgia.

34 (3) Any part of Glynn County which is described in subsection (a) of this section as  
35 being included in a particular commissioner district shall nevertheless not be included  
36 within such commissioner district if such part is not contiguous to such district. Such  
37 noncontiguous part shall instead be included within that particular commissioner district  
38 contiguous to such part which contains the least population according to the United States  
39 decennial census of 2020 for the State of Georgia."

40 "(e) Those members of the board of commissioners who are serving as such on the  
41 effective date of this Act and any person selected to fill a vacancy in any such office shall  
42 continue to serve as such members for the remainder of the terms of office to which they

43 were elected and until their respective successors are elected and qualified unless otherwise  
44 removed from office as provided by the Constitution and laws of this state."

45 "(h) Commissioner Districts 1, 2, 3, 4, and 5, as they exist on the effective date of this Act,  
46 shall continue to be designated as Commissioner Districts 1, 2, 3, 4, and 5, respectively,  
47 but as newly described under this Act, and on and after the effective date of this Act such  
48 members of the board of commissioners serving from those former commissioner districts  
49 shall be deemed to be serving from and representing their respective commissioner districts  
50 as newly described under this Act."

51 **SECTION 2.**

52 Said Act is further amended by striking in its entirety the attachment thereto containing the  
53 descriptions of education districts which is identified as "Plan: glynnccsb-2012rl Plan Type:  
54 local Administrator: glynn User: bak".

55 **SECTION 3.**

56 The provisions of this Act necessary to conduct elections for the members of the Board of  
57 Commissioners of Glynn County in 2022 shall become effective upon the approval of this  
58 Act by the Governor or upon its becoming law without such approval. The remaining  
59 provisions of this Act shall become effective on January 1, 2023.

60 **SECTION 4.**

61 All laws and parts of laws in conflict with this Act are repealed.
