## A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act reconstituting the Talbot County Board of Education, approved April 5,
- 2 1993 (Ga. L. 1993, p. 4710), as amended, particularly by an Act approved March 13, 2012
- 3 (Ga. L. 2012, p. 4310), so as to change the description of the education districts; to provide
- 4 for definitions and inclusions; to provide for continuation in office of current members; to
- 5 provide for related matters; to provide for effective dates; to repeal conflicting laws; and for
- 6 other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act reconstituting the Talbot County Board of Education, approved April 5, 1993 (Ga.
- 10 L. 1993, p. 4710), as amended, particularly by an Act approved March 13, 2012 (Ga. L.
- 11 2012, p. 4310), is amended by revising Section 2 as follows:
- 12 "SECTION 2.
- 13 (a) For purposes of electing members of the board of education, the Talbot County School
- District shall be divided into five education districts. Districts 1, 2, 3, 4, and 5 shall be and
- 15 correspond to those five numbered districts described in Appendix A attached to and made

a part of this Act and further identified as 'User: Talbot Co. Plan Name: Talbot CCSB-2022

- 17 Plan Type: Local'.
- 18 (b)(1) For the purposes of such plan:
- 19 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial
- 21 census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- Blocks within a VTD as provided in the report of the Bureau of the Census for the
- United States decennial census for 2020 for the State of Georgia; and
- 25 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 29 (2) Any part of the Talbot County School District which is not included in any district
- described in subsection (a) of this section shall be included within that district contiguous
- 31 to such part which contains the least population according to the United States decennial
- census of 2020 for the State of Georgia.
- 33 (3) Any part of the Talbot County School District which is described in subsection (a)
- of this section as being included in a particular district shall nevertheless not be included
- within such district if such part is not contiguous to such district. Such noncontiguous
- part shall instead be included within that district contiguous to such part which contains
- 37 the least population according to the United States decennial census of 2020 for the State
- 38 of Georgia."

39 SECTION 2.

- 40 (a) Those members of the Talbot County Board of Education who are serving as such on the
- 41 effective date of this Act and any person selected to fill a vacancy in any such office shall

42 continue to serve as such members until the regular expiration of their respective terms of

- 43 office and upon the election and qualification of their respective successors.
- 44 (b) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act,
- 45 shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly
- described under this Act, and on and after the effective date of this Act, such members of the
- 47 board serving from those former districts shall be deemed to be serving from and
- 48 representing their respective districts as newly described under this Act.

49 SECTION 3.

- 50 The provisions of this Act necessary to conduct elections for the members of the Talbot
- 51 County Board of Education in 2022 shall become effective upon the approval of this Act by
- 52 the Governor or upon its becoming law without such approval. The remaining provisions
- of this Act shall become effective on January 1, 2023.

SECTION 4.

All laws and parts of laws in conflict with this Act are repealed.
