

House Bill 1026 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act providing for the Board of Education of Madison County, approved
2 March 24, 1988 (Ga. L. 1988, p. 4698), as amended, particularly by an Act approved
3 March 5, 2012 (Ga. L. 2012, p. 4106), so as to revise the districts for the election of members
4 of the board of education; to provide for definitions and inclusions; to provide for
5 continuation in office of current members; to provide for related matters; to provide effective
6 dates; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act providing for the Board of Education of Madison County, approved March 24, 1988
10 (Ga. L. 1988, p. 4698), as amended, particularly by an Act approved March 5, 2012
11 (Ga. L. 2012, p. 4106), is amended by revising Section 3 as follows:

12 "SECTION 3.

13 (a) The Board of Education of Madison County shall be composed of five members. For
14 the purpose of electing the members of the board of education, the Madison County School
15 District shall be divided into five education districts. Education Districts 1 through 5 shall

16 be and correspond to those five numbered districts described in Appendix A attached to
17 and made a part of this Act and further identified as 'User: Madison Plan Name:
18 MadisonCCSB-2022 Plan Type: Local'.

19 (b)(1) For purposes of such plan:

20 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
21 provided in the report of the Bureau of the Census for the United States decennial
22 census of 2020 for the State of Georgia. The separate numeric designations in a district
23 description which are underneath a 'VTD' heading shall mean and describe individual
24 Blocks within a VTD as provided in the report of the Bureau of the Census for the
25 United States decennial census of 2020 for the State of Georgia; and

26 (B) Except as otherwise provided in the description of any district, whenever the
27 description of any district refers to a named city, it shall mean the geographical
28 boundaries of that city as shown on the census map for the United States decennial
29 census of 2020 for the State of Georgia.

30 (2) Any part of the Madison County School District which is not included in any district
31 described in subsection (a) of this section shall be included within that district contiguous
32 to such part which contains the least population according to the United States decennial
33 census of 2020 for the State of Georgia.

34 (3) Any part of the Madison County School District which is described in subsection (a)
35 of this section as being in a particular district shall nevertheless not be included within
36 such district if such part is not contiguous to such district. Such noncontiguous part shall
37 instead be included within that district contiguous to such part which contains the least
38 population according to the United States decennial census of 2020 for the State of
39 Georgia."

40 **SECTION 2.**

41 Said Act is further amended by repealing and reserving subsection (e) of Section 4.

42

SECTION 3.

43 (a) Those members of the Board of Education of Madison County who are serving as such
44 on the effective date of this Act and any person selected to fill a vacancy in any such office
45 shall continue to serve as such members until the regular expiration of their respective terms
46 of office and upon the election and qualification of their respective successors.

47 (b) Education Districts 1 through 5, as they exist immediately prior to the effective date of
48 this Act, shall continue to be designated as Education Districts 1 through 5, respectively, but
49 as newly described under this Act, and on and after the effective date of this Act, such
50 members of the board serving from those former districts shall be deemed to be serving from
51 and representing their respective districts as newly described under this Act.

52

SECTION 4.

53 The provisions of this Act necessary to conduct elections for the members of the board in
54 2022 shall become effective upon the approval of this Act by the Governor or upon its
55 becoming law without such approval. The remaining provisions of this Act shall become
56 effective January 1, 2023.

SECTION 5.

58 All laws and parts of laws in conflict with this Act are repealed.
