

House Bill 1027 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act creating a board of commissioners of Madison County, approved  
2 March 27, 1965 (Ga. L. 1965, p. 2667), as amended, particularly by an Act approved  
3 March 5, 2012 (Ga. L. 2012, p. 4112), so as to revise the districts for the election of members  
4 of the board of commissioners; to provide for definitions and inclusions; to provide for  
5 related matters; to provide for effective dates; to repeal conflicting laws; and for other  
6 purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act creating the Board of Commissioners of Madison County, approved March 27, 1965  
10 (Ga. L. 1965, p. 2667), as amended, particularly by an Act approved March 5, 2012  
11 (Ga. L. 2012, p. 4112), is amended by revising Section 2 as follows:

12 "SECTION 2.

13 (a) For the purpose of electing the members of the board of commissioners, Madison  
14 County shall be divided into five commissioner districts. Commissioner Districts 1 through  
15 5 shall be and correspond to those five numbered districts described in Appendix A

16 attached to and made a part of this Act and further identified as 'User: Madison Plan Name:  
17 MadisonCCSB-2022 Plan Type: Local'.

18 (b)(1) For purposes of such plan:

19 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
20 provided in the report of the Bureau of the Census for the United States decennial  
21 census of 2020 for the State of Georgia. The separate numeric designations in a district  
22 description which are underneath a 'VTD' heading shall mean and describe individual  
23 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
24 United States decennial census of 2020 for the State of Georgia.

25 (B) Except as otherwise provided in the description of any district, whenever the  
26 description of such district refers to a named city, it shall mean the geographical  
27 boundaries of that city as shown on the census map for the United States decennial  
28 census of 2020 for the State of Georgia.

29 (2) Any part of Madison County which is not included in any such district described in  
30 subsection (a) of this section shall be included within that district contiguous to such part  
31 which contains the least population according to the United States decennial census of  
32 2020 for the State of Georgia.

33 (3) Any part of Madison County which is described in subsection (a) of this section as  
34 being in a particular district shall nevertheless not be included within such district if such  
35 part is not contiguous to such district. Such noncontiguous part shall instead be included  
36 within that district contiguous to such part which contains the least population according  
37 to the United States decennial census of 2020 for the State of Georgia."

38 **SECTION 2.**

39 (a) Those members of the Board of Commissioners of Madison County who are serving as  
40 such on the effective date of this Act and any person selected to fill a vacancy in any such

41 office shall continue to serve as such members until the regular expiration of their respective  
42 terms of office and upon the election and qualification of their respective successors.

43 (b) Commissioner Districts 1 through 5, as they exist immediately prior to the effective date  
44 of this Act, shall continue to be designated as Commissioner Districts 1 through 5,  
45 respectively, but as newly described under this Act, and on and after the effective date of this  
46 Act, such members of the board serving from those former commissioner districts shall be  
47 deemed to be serving from and representing their respective districts as newly described  
48 under this Act.

49 **SECTION 3.**

50 The provisions of this Act necessary to conduct elections for the members of the board in  
51 2022 shall become effective upon the approval of this Act by the Governor or upon its  
52 becoming law without such approval. The remaining provisions of this Act shall become  
53 effective on January 1, 2023.

54 **SECTION 4.**

55 All laws and parts of laws in conflict with this Act are repealed.
