

House Bill 1075 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act establishing a board of commissioners of roads and revenues for the  
2 County of Jenkins, approved August 1, 1911 (Ga. L. 1911, p. 449), as amended, particularly  
3 by an Act approved March 27, 2012 (Ga. L. 2012, p. 4535), so as to revise the districts for  
4 the election of members of the board of commissioners; to provide for definitions and  
5 inclusions; to provide for continuation in office; to provide for related matters; to provide  
6 effective dates; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act establishing a board of commissioners of roads and revenues for the County of  
10 Jenkins, approved August 1, 1911 (Ga. L. 1911, p. 449), as amended, particularly by an Act  
11 approved March 27, 2012 (Ga. L. 2012, p. 4535), is amended by revising subsections (a)  
12 through (f) of Section 3 as follows:

13 "(a) For the purpose of electing members of the board of commissioners, Jenkins County  
14 is divided into five districts. Such districts shall be and correspond to those five numbered  
15 districts described in Appendix A attached to and made a part of this Act and further  
16 identified as 'User: Jenkins Co. Plan Name: JenkinsCCSB-2022 Plan Type: Local'.

17 (b) For the purposes of such plan:

18 (1) The term 'VTD' shall mean and describe the same geographical boundaries as  
19 provided in the report of the Bureau of the Census for the United States decennial census  
20 of 2020 for the State of Georgia. The separate numeric designations in a district  
21 description which are underneath a VTD heading shall mean and describe individual  
22 Blocks within a VTD as provided in the report of the Bureau of the Census for the United  
23 States decennial census of 2020 for the State of Georgia; and

24 (2) Except as otherwise provided in the description of any district, whenever the  
25 description of any district refers to a named city, it shall mean the geographical  
26 boundaries of that city as shown on the census maps for the United States decennial  
27 census of 2020 for the State of Georgia.

28 (c) Any part of Jenkins County which is not included in any district described in  
29 subsection (a) of this section shall be included within that district contiguous to such part  
30 which contains the least population according to the United States decennial census of 2020  
31 for the State of Georgia.

32 (d) Any part of Jenkins County which is described in subsection (a) of this section as being  
33 included in a particular district shall nevertheless not be included within such district if  
34 such part is not contiguous to such district. Such noncontiguous part shall instead be  
35 included within that district contiguous to such part which contains the least population  
36 according to the United States decennial census of 2020 for the State of Georgia.

37 (e) One commissioner shall be elected from each commissioner district by the voters  
38 residing therein. Each commissioner shall be a resident of the commissioner district he or  
39 she represents. No person shall be a candidate for the office of commissioner who does not  
40 reside within the commissioner district which he or she seeks to represent.

41 (f)(1) The commissioners for Commissioner Districts 1, 3, and 4 shall be elected at the  
42 state-wide general election in 2024. The commissioners for Commissioner Districts 2  
43 and 5 shall be elected at the state-wide general election in 2022. Such members shall take

44 office on January 1 following their election for terms of four years and until their  
45 successors are elected and qualified.

46 (2) Successors to members elected under paragraph (1) of this subsection shall be elected  
47 at the state-wide general election next preceding the expiration of such terms of office  
48 and shall take office on January 1 following their election for terms of four years and  
49 until their successors are elected and qualified.”

50 **SECTION 2.**

51 (a) Those members of the Board of Commissioners of Jenkins County who are serving as  
52 such on the effective date of this Act and any person selected to fill a vacancy in any such  
53 office shall continue to serve as such members until the regular expiration of their respective  
54 terms of office and upon the election and qualification of their respective successors.

55 (b) Commissioner Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective  
56 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, 4, and 5,  
57 respectively, but as newly described under this Act, and on and after the effective date of this  
58 Act, such members of the board serving from those former commissioner districts shall be  
59 deemed to be serving from and representing their respective districts as newly described  
60 under this Act.

61 **SECTION 3.**

62 The provisions of this Act relating to and necessary for the regular election in 2022 of  
63 members of the Board of Commissioners of Jenkins County shall become effective upon  
64 approval of this Act by the Governor or upon its becoming effective without such approval;  
65 and this Act shall otherwise become effective January 1, 2023.

66 **SECTION 4.**

67 All laws and parts of laws in conflict with this Act are repealed.
