

House Bill 1081 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act creating a new Board of Education of Jenkins County, approved April 3,
2 1968 (Ga. L. 1968, p. 2965), as amended, particularly by an Act approved March 27, 2012
3 (Ga. L. 2012, p. 4541), so as to revise the districts for the election of members of the board
4 of education; to provide for definitions and inclusions; to provide for continuation in office;
5 to provide for related matters; to provide effective dates; to repeal conflicting laws; and for
6 other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act creating a new Board of Education of Jenkins County, approved April 3, 1968
10 (Ga. L. 1968, p. 2965), as amended, particularly by an Act approved March 27, 2012 (Ga.
11 L. 2012, p. 4541), is amended by revising subsections (b) through (e) of Section 1 as follows:
12 "(b) For the purpose of electing members of the Board of Education of Jenkins County, the
13 Jenkins County School District shall be divided into five education districts. The districts
14 shall be and correspond to those five numbered districts described in Appendix A attached
15 to and made a part of this Act and further identified as 'User: Jenkins Co. Plan Name:
16 JenkinsCCSB-2022 Plan Type: Local'.

17 (c) For purposes of such plan:

18 (1) The term 'VTD' shall mean and describe the same geographical boundaries as
19 provided in the report of the Bureau of the Census for the United States decennial census
20 of 2020 for the State of Georgia. The separate numeric designations in a district
21 description which are underneath a VTD heading shall mean and describe individual
22 Blocks within a VTD as provided in the report of the Bureau of the Census for the United
23 States decennial census of 2020 for the State of Georgia.

24 (2) Except as otherwise provided in the description of any district, whenever the
25 description of any district refers to a named city, it shall mean the geographical
26 boundaries of that city as shown on the census maps for the United States decennial
27 census of 2020 for the State of Georgia.

28 (d) Any part of Jenkins County which is not included in any such district described in
29 subsection (b) of this section shall be included within that district contiguous to such part
30 which contains the least population according to the United States decennial census of 2020
31 for the State of Georgia.

32 (e) Any part of Jenkins County which is described in subsection (b) of this section as being
33 in a particular district shall nevertheless not be included within such district if such part is
34 not contiguous to such district. Such noncontiguous part shall instead be included within
35 that district contiguous to such part which contains the least population according to the
36 United States decennial census of 2020 for the State of Georgia."

37 **SECTION 2.**

38 Said Act is further amended by repealing and reserving subsection (e) of Section 2.

39 **SECTION 3.**

40 (a) Those members of the Board of Education of Jenkins County who are serving as such
41 on the effective date of this Act and any person selected to fill a vacancy in any such office

42 shall continue to serve as such members until the regular expiration of their respective terms
43 of office and upon the election and qualification of their respective successors.

44 (b) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act,
45 shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly
46 described under this Act, and on and after the effective date of this Act, such members of the
47 board serving from those former districts shall be deemed to be serving from and
48 representing their respective districts as newly described under this Act.

49 **SECTION 4.**

50 The provisions of this Act relating to and necessary for the regular election in 2022 of
51 members of the Board of Education of Jenkins County shall become effective upon its
52 approval by the Governor or upon its becoming effective without such approval. This Act
53 shall otherwise become effective January 1, 2023.

54 **SECTION 5.**

55 All laws and parts of laws in conflict with this Act are repealed.
