

House Bill 1082 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act recreating the Board of Commissioners of Wilkes County, approved
2 April 17, 1975 (Ga. L. 1975, p. 2979), as amended, particularly by an Act approved
3 September 21, 2011 (Ga. L. 2011 Ex. Sess., p. 437), so as to change the description of the
4 commissioner districts; to provide for continuation in office of certain current board
5 members; to provide for effective dates; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act recreating the Board of Commissioners of Wilkes County, approved April 17, 1975
9 (Ga. L. 1975, p. 2979), as amended, particularly by an Act approved September 21, 2011
10 (Ga. L. 2011 Ex. Sess., p. 437), is amended by revising subsections (c), (d), and (i) of
11 Section 3 as follows:

12 "(c) For purposes of electing members of the board of commissioners, other than the
13 chairperson, Wilkes County is divided into four commissioner districts. One member of
14 the board shall be elected from each such district. The four commissioner districts shall
15 be and correspond to those four numbered districts described in Appendix A attached to

16 and made a part of this Act and further identified as 'User: Wilkes Co. Plan Name:
17 WilkesCCSB-2022 Plan Type: Local'.

18 (d)(1) For the purposes of such plan:

19 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
20 provided in the report of the Bureau of the Census for the United States decennial
21 census of 2020 for the State of Georgia. The separate numeric designations in a district
22 description which are underneath a VTD heading shall mean and describe individual
23 Blocks within a VTD as provided in the report of the Bureau of the Census for the
24 United States decennial census of 2020 for the State of Georgia; and

25 (B) Except as otherwise provided in the description of any district, whenever the
26 description of any district refers to a named city, it shall mean the geographical
27 boundaries of that city as shown on the census maps for the United States decennial
28 census of 2020 for the State of Georgia.

29 (2) Any part of Wilkes County which is not included in any district described in
30 subsection (c) of this section shall be included within that district contiguous to such part
31 which contains the least population according to the United States decennial census
32 of 2020 for the State of Georgia.

33 (3) Any part of Wilkes County which is described in subsection (c) of this section as
34 being included in a particular district shall nevertheless not be included within such
35 district if such part is not contiguous to such district. Such noncontiguous part shall
36 instead be included within that district contiguous to such part which contains the least
37 population according to the United States decennial census of 2020 for the State of
38 Georgia."

39 "(i) Districts 1, 2, 3, and 4, as they exist immediately prior to the effective date of this Act,
40 shall continue to be designated as Districts 1, 2, 3, and 4, respectively, but as newly
41 described under this Act, and on and after the effective date of this Act, such members of

42 the board serving from those former commissioner districts shall be deemed to be serving
43 from and representing their respective districts as newly described under this Act.”

44 **SECTION 2.**

45 Those members of the Board of Commissioners of Wilkes County who are serving as such
46 on the effective date of this Act and any person selected to fill a vacancy in any such office
47 shall continue to serve as such members until the regular expiration of their respective terms
48 of office and upon the election and qualification of their respective successors.

49 **SECTION 3.**

50 The provisions of this Act necessary to conduct elections for the members of the Board of
51 Commissioners of Wilkes County in 2022 shall become effective upon the approval of this
52 Act by the Governor or upon its becoming law without such approval. The remaining
53 provisions of this Act shall become effective on January 1, 2023.

54 **SECTION 4.**

55 All laws and parts of laws in conflict with this Act are repealed.
