# A BILL TO BE ENTITLED AN ACT

1 To amend an Act establishing the Griffin-Spalding County School System Board of Education, approved February 25, 1953 (Ga. L. 1953, Jan.-Feb. Sess., p. 2563), as amended, 2 3 particularly by a local constitutional amendment (Ga. L. 1982, p. 2680) which was continued in force and effect as a part of the Constitution of the State of Georgia by an Act approved 4 February 18, 1987 (Ga. L. 1987, p. 3545), by an Act approved March 7, 2002 5 (Ga. L. 2002, p. 3566), and by an Act approved September 21, 2011 6 7 (Ga. L. 2011, Ex. Sess., p. 478), so as to reconstitute the Griffin-Spalding County Board of 8 Education; to change the description of the education districts; to provide for definitions and 9 inclusions; to provide for continuation in office of certain current board members; to provide 10 for election of and qualifications for subsequent members; to provide for related matters; to 11 provide for a referendum, effective dates, and automatic repeal; to repeal conflicting laws; 12 and for other purposes.

- 13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

#### **SECTION 1.**

An Act establishing the Griffin-Spalding County School System Board of Education,
approved February 25, 1953 (Ga. L. 1953, Jan.-Feb. Sess., p. 2563), as amended, particularly

by a local constitutional amendment (Ga. L. 1982, p. 2680) which was continued in force and
effect as a part of the Constitution of the State of Georgia by an Act approved
February 18, 1987 (Ga. L. 1987, p. 3545), by an Act approved March 7, 2002
(Ga. L. 2002, p. 3566), and by an Act approved September 21, 2011
(Ga. L. 2011, Ex. Sess., p. 478), is amended by revising Sections 2 and 3 as follows:

22

### "SECTION 2.

23 (a) The administration of the Griffin-Spalding County School System shall be vested in a 24 board to be known and designated as the 'Griffin-Spalding County Board of Education.' Said 25 board shall consist of five members, each of whom shall be a person of good moral character and at least 25 years of age at the time of assuming office as a member of said board. Each 26 27 of the five education districts hereinafter created and described shall be represented by one member of such board who shall have been a resident of the district he or she represents for 28 29 at least six months prior to the date of his or her election or appointment to said board. Such 30 members shall be elected in a nonpartisan general election held at the time of the general 31 primary in each even-numbered year.

(b)(1) For the purpose of electing members of the board of education, the
Griffin-Spalding County School District shall be divided into five education districts.
Districts 1, 2, 3, 4, and 5 shall be and correspond to those five numbered districts
described in Appendix A attached to and made a part of this Act and further identified as
'User: Spalding Co. Plan Name: SpaldingCCSB-2022 Plan Type: Local'.

37 (2) For the purposes of such plan:

(A) The term 'VTD' shall mean and describe the same geographical boundaries as
provided in the report of the Bureau of the Census for the United States decennial
census of 2020 for the State of Georgia. The separate numeric designations in a district
description which are underneath a VTD heading shall mean and describe individual

Blocks within a VTD as provided in the report of the Bureau of the Census for the
United States decennial census of 2020 for the State of Georgia; and

- (B) Except as otherwise provided in the description of any district, whenever the
  description of any district refers to a named city, it shall mean the geographical
  boundaries of that city as shown on the census maps for the United States decennial
  census of 2020 for the State of Georgia.
- (3) Any part of the Griffin-Spalding County School District which is not included in any
  district described in paragraph (1) of this subsection shall be included within that district
  contiguous to such part which contains the least population according to the United States
  decennial census of 2020 for the State of Georgia.
- (4) Any part of the Griffin-Spalding County School District which is described in paragraph (1) of this subsection as being included in a particular district shall nevertheless not be included within such district if such part is not contiguous to such district. Such noncontiguous part shall instead be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia.

#### SECTION 3.

(a) Those members of the Griffin-Spalding County Board of Education who are serving as
such on the effective date of this Act and any person selected to fill a vacancy in any such
office shall continue to serve as such members until the regular expiration of their respective
terms of office and upon the election and qualification of their respective successors.

(b) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act,
shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly
described under this Act, and on and after the effective date of this Act, such members of the
board serving from those former districts shall be deemed to be serving from and
representing their respective districts as newly described under this Act."

#### **SECTION 2.**

69 The election superintendent of Spalding County shall call and conduct an election as 70 provided in this section for the purpose of submitting this Act to the electors of Spalding 71 County for approval or rejection. The election superintendent shall conduct that election on 72 the date of the November, 2022, general election and shall issue the call and conduct that 73 election as provided by general law. The election superintendent shall cause the date and 74 purpose of the election to be published once a week for two weeks immediately preceding 75 the date thereof in the official organ of Spalding County. The ballot shall have written or 76 printed thereon the words:

"() YES Shall the Griffin-Spalding County Board of Education be permitted to
() NO change the description of the education districts in accordance with the
report of the Bureau of the Census for the United States decennial census
of 2020 so as to comply with the federal law?"

All persons desiring to vote for approval of the Act shall vote "Yes," and all persons desiring 81 82 to vote for rejection of the Act shall vote "No." If more than one-half of the votes cast on 83 such question are for approval of the Act, then Section 1 of this Act shall become of full force and effect on January 1, 2023. If the Act is not so approved or if the election is not 84 85 conducted as provided in this section, then Section 1 of this Act shall not become effective, 86 and this Act shall be automatically repealed on the first day of January immediately 87 following that election date. The expense of such election shall be borne by Spalding County. 88 It shall be the election superintendent's duty to certify the result thereof to the Secretary of 89 State.
