

House Bill 1110 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act creating the Board of Commissioners of Spalding County, approved
2 February 5, 1873 (Ga. L. 1873, p. 289), as amended, particularly by an Act approved
3 March 15, 2002 (Ga. L. 2002, p. 3591) and by an Act approved September 21, 2011
4 (GA. L. 2011 Ex. Sess., p. 471), so as to reconstitute the board of commissioners; to change
5 the description of the commissioner districts; to provide for definitions and inclusions; to
6 provide for election and terms of office of subsequent members; to provide for effective
7 dates; to repeal conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 An Act creating the Board of Commissioners of Spalding County, approved
11 February 5, 1873 (Ga. L. 1873, p. 289), as amended, particularly by an Act approved
12 March 15, 2002 (Ga. L. 2002, p. 3591) and by an Act approved September 21, 2011
13 (GA. L. 2011 Ex. Sess., p. 471), is amended by revising subsection (c) of Section 1 as
14 follows:

15 "(c)(1) For the purpose of electing members of the board of commissioners, Spalding
16 County shall be divided into five commissioner districts. Commissioner

17 Districts 1, 2, 3, 4, and 5 shall be and correspond to those five numbered districts
18 described in Appendix A attached to and made a part of this Act and further identified as
19 'User: Spalding Co. Plan Name: SpaldingCCSB-2022 Plan Type: Local'.

20 (2)(A) For the purposes of such plan:

21 (i) The term 'VTD' shall mean and describe the same geographical boundaries as
22 provided in the report of the Bureau of the Census for the United States decennial
23 census of 2020 for the State of Georgia. The separate numeric designations in a
24 district description which are underneath a VTD heading shall mean and describe
25 individual Blocks within a VTD as provided in the report of the Bureau of the Census
26 for the United States decennial census of 2020 for the State of Georgia; and

27 (ii) Except as otherwise provided in the description of any district, whenever the
28 description of any district refers to a named city, it shall mean the geographical
29 boundaries of that city as shown on the census maps for the United States decennial
30 census of 2020 for the State of Georgia.

31 (B) Any part of Spalding County which is not included in any district described in
32 paragraph (1) of subsection (c) of this section shall be included within that district
33 contiguous to such part which contains the least population according to the United
34 States decennial census of 2020 for the State of Georgia.

35 (C) Any part of Spalding County which is described in paragraph (1) of subsection (c)
36 of this section as being included in a particular district shall nevertheless not be
37 included within such district if such part is not contiguous to such district. Such
38 noncontiguous part shall instead be included within that district contiguous to such part
39 which contains the least population according to the United States decennial census of
40 2020 for the State of Georgia.

41 (3) No person shall be a member of the board if that person is ineligible for such office
42 pursuant to Code Section 45-2-1 of the O.C.G.A. or any other general law applicable to
43 that office. The members of the board shall be residents of the commissioner districts

44 they represent and shall be elected by the qualified electors voting within their respective
45 commissioner districts."

46 **SECTION 2.**

47 (a) Those members of the Board of Commissioners of Spalding County who are serving as
48 such on the effective date of this Act and any person selected to fill a vacancy in any such
49 office shall continue to serve as such members until the regular expiration of their respective
50 terms of office and upon the election and qualification of their respective successors.

51 (b) Commissioner Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective
52 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, 4, and 5,
53 respectively, but as newly described under this Act, and on and after the effective date of this
54 Act, such members of the board serving from those former commissioner districts shall be
55 deemed to be serving from and representing their respective districts as newly described
56 under this Act.

57 **SECTION 3.**

58 Those provisions of this Act necessary for the election of members of the Board of
59 Commissioners of Spalding County in 2022 shall become effective upon the approval of this
60 Act by the Governor or upon its becoming law without such approval. The remaining
61 provisions of this Act shall become effective January 1, 2023.

62 **SECTION 4.**

63 All laws and parts of laws in conflict with this Act are repealed.
