

House Bill 1123 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act providing for the Board of Education of Glynn County, approved  
2 February 21, 1873 (Ga. L. 1873, p. 256), as amended, particularly by an Act approved  
3 August 12, 1914 (Ga. L. 1914, p. 275), and by an Act approved February 27, 2012 (Ga.  
4 L. 2012, p. 3636), so as to provide new district boundaries; to provide for definitions and  
5 inclusions; to provide for the manner of election; to provide for continuation in office of the  
6 current members; to provide for related matters; to provide for effective dates; to repeal  
7 conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 An Act providing for the Board of Education of Glynn County, approved February 21, 1873  
11 (Ga. L. 1873, p. 256), as amended, particularly by an Act approved August 12, 1914 (Ga. L.  
12 1914, p. 275), and by an Act approved February 27, 2012 (Ga. L. 2012, p. 3636), is amended  
13 by revising subsections (a) and (b) of Section 1 as follows:

14 "(a) The Board of Education of Glynn County shall be composed of seven elected  
15 members as provided in subsection (b) of this section. Those members of the Board of  
16 Education of Glynn County who are serving as such on the effective date of this Act and

17 any person selected to fill a vacancy in any such offices shall continue to serve as such  
18 members for the remainder of the terms of office to which they were elected and until their  
19 successors are elected and qualified.

20 (b)(1) For the purpose of electing five members of the board of education, the Glynn  
21 County School District shall be divided into five education districts. Education Districts  
22 1, 2, 3, 4, and 5 shall be and correspond to those five numbered districts described in  
23 Appendix A attached to and made a part of this Act and further identified as 'User: Glynn  
24 Plan Name: GlynnCCSB-2022 Plan Type: Local'.

25 (2) For the purposes of such plan:

26 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
27 provided in the report of the Bureau of the Census for the United States decennial  
28 census of 2020 for the State of Georgia. The separate numeric designations in a district  
29 description which are underneath a VTD heading shall mean and describe individual  
30 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
31 United States decennial census of 2020 for the State of Georgia; and

32 (B) Except as otherwise provided in the description of any district, whenever the  
33 description of any district refers to a named city, it shall mean the geographical  
34 boundaries of that city as shown on the census maps for the United States decennial  
35 census of 2020 for the State of Georgia.

36 (3) Any part of the Glynn County School District which is not included in any education  
37 district described in paragraph (1) of this subsection shall be included within that  
38 education district contiguous to such part which contains the least population according  
39 to the United States decennial census of 2020 for the State of Georgia.

40 (4) Any part of the Glynn County School District which is described in paragraph (1) of  
41 this subsection as being included in a particular education district shall nevertheless not  
42 be included within such education district if such part is not contiguous to such education  
43 district. Such noncontiguous part shall instead be included within that education district

44 contiguous to such part which contains the least population according to the United States  
45 decennial census of 2020 for the State of Georgia.

46 (5) Two at-large positions on the board are designated at-large Post 1 and at-large Post 2.  
47 Members elected to those at-large positions shall be elected by the qualified voters of the  
48 entire Glynn County School District voting in an election therefor. Candidates for  
49 election as at-large members shall designate the post for which they are candidates. At  
50 the general election in 2014, there shall be elected a successor to at-large Post 1. Such  
51 successor shall take office the first day of January immediately following that election  
52 and serve for a term of office of four years and until his or her successor is elected and  
53 qualified. At the general election in 2012, there shall be elected a successor to at-large  
54 Post 2. Such successor shall take office the first day of January immediately following  
55 that election and serve for a term of office of four years and until his or her successor is  
56 elected and qualified. Thereafter, successors shall be elected at the general election  
57 immediately preceding the end of their terms of office, shall take office on the first day  
58 of January immediately following such election, and shall serve terms of office of four  
59 years each and until their respective successors are elected and qualified.

60 (6) Successors to those members of the board elected in 2008 from Education  
61 Districts 1, 3, and 5 and persons selected to fill any vacancy in such positions whose  
62 terms of office are to expire at the end of December 31, 2012, shall be elected at the  
63 general election in 2012, shall take office the first day of January immediately following  
64 that election, and shall serve for terms of office of four years each and until the election  
65 and qualification of their respective successors. Successors to those members of the  
66 board elected in 2010 from Education Districts 2 and 4 and persons selected to fill any  
67 vacancy in such positions whose terms of office are to expire at the end of  
68 December 31, 2014, shall be elected at the general election in 2014, shall take office the  
69 first day of January immediately following that election, and shall serve for terms of  
70 office of four years each and until the election and qualification of their respective

71 successors. Thereafter, successors shall be elected at the general election immediately  
72 preceding the end of their terms of office, shall take office on the first day of January  
73 immediately following such election, and shall serve terms of office of four years each  
74 and until their respective successors are elected and qualified.

75 (7) Each candidate for election to an education district of the board of education shall be  
76 a resident of Glynn County and the respective education district which he or she seeks  
77 to represent and shall be elected only by the qualified electors of such education district.

78 (8) All elections for members of the board shall be conducted in accordance with  
79 Chapter 2 of Title 21 of the O.C.G.A., the 'Georgia Election Code', as now or hereafter  
80 amended."

81 **SECTION 2.**

82 Said Act is further amended by striking in its entirety the attachment thereto containing the  
83 descriptions of education districts which is identified as "Plan: glynncosb-2012r1 Plan Type:  
84 local Administrator: glynn User: bak".

85 **SECTION 3.**

86 The provisions of this Act necessary to conduct elections for the members of the Board of  
87 Education of Glynn County in 2022 shall become effective upon the approval of this Act by  
88 the Governor or upon its becoming law without such approval. The remaining provisions  
89 of this Act shall become effective on January 1, 2023.

90 **SECTION 4.**

91 All laws and parts of laws in conflict with this Act are repealed.
