

House Bill 1139 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act providing for the election of members of the board of education of Tattnall  
2 County, approved February 29, 1968 (Ga. L. 1968, p. 2077), as amended, particularly by an  
3 Act approved April 4, 2012 (Ga. L. 2022, p. 4654), so as to change the description of the  
4 education districts; to define certain terms and provide for certain inclusions; to provide for  
5 continuation in office of current members; to provide for related matters; to provide effective  
6 dates; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act providing for the election of members of the board of education of Tattnall County,  
10 approved February 29, 1968 (Ga. L. 1968, p. 2077), as amended, particularly by an Act  
11 approved April 4, 2012 (Ga. L. 2022, p. 4654), is amended by revising Section 2 as follows:

12 "SECTION 2.

13 (a) For the purpose of electing members of the Board of Education of Tattnall County, the  
14 Tattnall County School District is divided into five districts. Such districts shall be and  
15 correspond to those five numbered districts described in Appendix A attached to and made

16 a part of this Act and further identified as 'User: Tattnall Co. Plan Name: TattnallCCSB-2022  
17 Plan Type: Local'.

18 (b)(1) For the purposes of such plan:

19 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
20 provided in the report of the Bureau of the Census for the United States decennial  
21 census of 2020 for the State of Georgia. The separate numeric designations in a district  
22 description which are underneath a VTD heading shall mean and describe individual  
23 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
24 United States decennial census of 2020 for the State of Georgia; and

25 (B) Except as otherwise provided in the description of any district, whenever the  
26 description of any district refers to a named city, it shall mean the geographical  
27 boundaries of that city as shown on the census maps for the United States decennial  
28 census of 2020 for the State of Georgia.

29 (2) Any part of the Tattnall County School District which is not included in any district  
30 described in subsection (a) of this section shall be included within that district contiguous  
31 to such part which contains the least population according to the United States decennial  
32 census of 2020 for the State of Georgia.

33 (3) Any part of the Tattnall County School District which is described in subsection (a)  
34 of this section as being included in a particular district shall nevertheless not be included  
35 within such district if such part is not contiguous to such district. Such noncontiguous  
36 part shall instead be included within that district contiguous to such part which contains  
37 the least population according to the United States decennial census of 2020 for the State  
38 of Georgia."

## SECTION 2.

40 (a) Those members of the Board of Education of Tattnall County who are serving as such  
41 on the effective date of this Act and any person selected to fill a vacancy in any such office

42 shall continue to serve as such members until the regular expiration of their respective terms  
43 of office and upon the election and qualification of their respective successors.

44 (b) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act,  
45 shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly  
46 described under this Act, and on and after the effective date of this Act, such members of the  
47 board serving from those former districts shall be deemed to be serving from and  
48 representing their respective districts as newly described under this Act.

49 **SECTION 3.**

50 The provisions of this Act necessary to conduct elections for the members of the Board of  
51 Education of Tattnall County in 2022 shall become effective upon the approval of this Act  
52 by the Governor or upon its becoming law without such approval. The remaining provisions  
53 of this Act shall become effective on January 1, 2023.

54 **SECTION 4.**

55 All laws and parts of laws in conflict with this Act are repealed.
