A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating the Board of Commissioners of Clay County, approved
- 2 February 16, 1953 (Ga. L. 1953, Jan.-Feb. Sess., p. 2326), as amended, particularly by an Act
- 3 approved September 21, 2011 (Ga. L. 2011, Ex. Sess., p. 368), so as to change the
- 4 description of the commissioner districts for the election of members of the board of
- 5 commissioners; to provide for definitions and inclusions; to provide for the continuation in
- 6 office of current members; to provide for related matters; to provide for effective dates; to
- 7 repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 SECTION 1.

- 10 An Act creating the Board of Commissioners of Clay County, approved February 16, 1953
- 11 (Ga. L. 1953, Jan.-Feb. Sess., p. 2326), as amended, particularly by an Act approved
- 12 September 21, 2011 (Ga. L. 2011, Ex. Sess., p. 368), is amended by revising Section 1 as
- 13 follows:

14 "SECTION 1.

15 (a) For the purpose of electing members of the board of commissioners, Clay County shall

- be divided into five commissioner districts. Commissioner Districts 1, 2, 3, 4, and 5 shall
- 17 be and correspond to those five numbered districts described in and attached to and made a
- part of this Act and further identified as 'User: Clay Co. Plan Name: ClayCCSB-2022 Plan
- 19 Type: Local'.
- 20 (b)(1) For the purposes of such plan:
- 21 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial
- census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- 25 Blocks within a VTD as provided in the report of the Bureau of the Census for the
- 26 United States decennial census of 2020 for the State of Georgia; and
- 27 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 31 (2) Any part of Clay County which is not included in any district described in
- 32 subsection (a) of this section shall be included within that district contiguous to such part
- which contains the least population according to the United States decennial census
- of 2020 for the State of Georgia.
- 35 (3) Any part of Clay County which is described in subsection (a) of this section as being
- included in a particular district shall nevertheless not be included within such district if
- such part is not contiguous to such district. Such noncontiguous part shall instead be
- included within that district contiguous to such part which contains the least population
- according to the United States decennial census of 2020 for the State of Georgia."

40 **SECTION 2.**

- 41 (a) Those members of the Board of Commissioners of Clay County who are serving as such
- 42 on the effective date of this Act and any person selected to fill a vacancy in any such office
- 43 shall continue to serve as such members until the regular expiration of their respective terms
- of office and upon the election and qualification of their respective successors.
- 45 (b) Commissioner Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective
- date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, 4, and 5,
- 47 respectively, but as newly described under this Act, and on and after the effective date of this
- 48 Act, such members of the board serving from those former commissioner districts shall be
- 49 deemed to be serving from and representing their respective districts as newly described
- 50 under this Act.

SECTION 3.

- 52 The provisions of this Act necessary to conduct elections for the members of the Board of
- 53 Commissioners of Clay County in 2022 shall become effective upon the approval of this Act
- by the Governor or upon its becoming law without such approval. The remaining provisions
- of this Act shall become effective on January 1, 2023.

SECTION 4.

57 All laws and parts of laws in conflict with this Act are repealed.
