A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act reconstituting the Board of Education of Clay County, approved
- 2 January 15, 1993 (Ga. L. 1993, p. 3576), as amended, particularly by an Act approved
- 3 September 21, 2011 (Ga. L. 2011, Ex. Sess., p. 376), so as to change the description of the
- 4 education districts; to provide for definitions and inclusions; to provide for the continuation
- 5 in office of current members; to provide for effective dates; to repeal conflicting laws; and
- 6 for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act reconstituting the Board of Education of Clay County, approved January 15, 1993
- 10 (Ga. L. 1993, p. 3576), as amended, particularly by an Act approved September 21, 2011
- 11 (Ga. L. 2011, Ex. Sess., p. 376), is amended by revising Section 1 as follows:
- 12 "SECTION 1.
- 13 (a) For the purpose of electing members of the board of education, Clay County shall be
- 14 divided into five education districts. Education Districts 1, 2, 3, 4, and 5 shall be and
- 15 correspond to those five numbered districts described in and attached to and made a part of

this Act and further identified as 'User: Clay Co. Plan Name: ClayCCSB-2022 Plan Type:

- 17 Local'.
- 18 (b)(1) For the purposes of such plan:
- 19 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial
- 21 census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- Blocks within a VTD as provided in the report of the Bureau of the Census for the
- United States decennial census of 2020 for the State of Georgia; and
- 25 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 29 (2) Any part of the Clay County school district which is not included in any district
- described in subsection (a) of this section shall be included within that district contiguous
- 31 to such part which contains the least population according to the United States decennial
- census of 2020 for the State of Georgia.
- 33 (3) Any part of the Clay County school district which is described in subsection (a) of
- 34 this section as being included in a particular district shall nevertheless not be included
- within such district if such part is not contiguous to such district. Such noncontiguous
- part shall instead be included within that district contiguous to such part which contains
- 37 the least population according to the United States decennial census of 2020 for the State
- of Georgia.

39 SECTION 2.

- 40 (a) Those members of the Board of Education of Clay County who are serving as such on
- 41 the effective date of this Act and any person selected to fill a vacancy in any such office shall

42 continue to serve as such members until the regular expiration of their respective terms of

- 43 office and upon the election and qualification of their respective successors.
- 44 (b) Education Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date
- 45 of this Act, shall continue to be designated as Education Districts 1, 2, 3, 4, and 5,
- 46 respectively, but as newly described under this Act, and on and after the effective date of this
- 47 Act, such members of the board serving from those former education districts shall be
- 48 deemed to be serving from and representing their respective districts as newly described
- 49 under this Act.

SECTION 3.

- 51 The provisions of this Act necessary to conduct elections for the members of the Board of
- 52 Education of Clay County in 2022 shall become effective upon the approval of this Act by
- 53 the Governor or upon its becoming law without such approval. The remaining provisions
- of this Act shall become effective on January 1, 2023.

SECTION 4.

All laws and parts of laws in conflict with this Act are repealed.
