

House Bill 1167 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act reconstituting the Board of Education of Taliaferro County, approved  
2 February 4, 1993 (Ga. L. 1993, p. 3643), as amended, so as to change the descriptions of the  
3 education districts; to provide for continuation in office of current members; to provide for  
4 definitions and inclusions; to provide for related matters; to provide for effective dates; to  
5 repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act reconstituting the Board of Education of Taliaferro County, approved  
9 February 4, 1993 (Ga. L. 1993, p. 3643), as amended, is amended by revising Section 2 and  
10 Section 4 as follows:

11 **"Section 2.** (a) For the purpose of electing members of the board of education, the  
12 Taliaferro County School District shall be divided into five education districts. One  
13 member of the board, which shall consist of five members, shall be elected from each such  
14 district. Districts 1, 2, 3, 4, and 5 shall be and correspond to those five numbered districts  
15 described in Appendix A attached to and made a part of this Act and further identified as  
16 'User: Taliaferro SB Plan Name: TaliaferroSB-2022 Plan Type: Local'.

17 (b)(1) For the purposes of such plan:

18 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
19 provided in the report of the Bureau of the Census for the United States decennial  
20 census of 2020 for the State of Georgia. The separate numeric designations in a district  
21 description which are underneath a VTD heading shall mean and describe individual  
22 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
23 United States decennial census of 2020 for the State of Georgia; and

24 (B) Except as otherwise provided in the description of any district, whenever the  
25 description of any district refers to a named city, it shall mean the geographical  
26 boundaries of that city as shown on the census maps for the United States decennial  
27 census of 2020 for the State of Georgia.

28 (2) Any part of the Taliaferro County School District which is not included in any district  
29 described in subsection (a) of this section shall be included within that district contiguous  
30 to such part which contains the least population according to the United States decennial  
31 census of 2020 for the State of Georgia.

32 (3) Any part of the Taliaferro County School District which is described in subsection (a)  
33 of this section as being included in a particular district shall nevertheless not be included  
34 within such district if such part is not contiguous to such district. Such noncontiguous  
35 part shall instead be included within that district contiguous to such part which contains  
36 the least population according to the United States decennial census of 2020 for the State  
37 of Georgia."

38 "**Section 4.** (a) Those members of the Board of Education of Taliaferro County who are  
39 serving as such on the effective date of this Act and any person selected to fill a vacancy  
40 in any such office shall continue to serve as such members until the regular expiration of  
41 their respective terms of office and upon the election and qualification of their respective  
42 successors.

43 (b) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act,  
44 shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly  
45 described under this Act, and on and after the effective date of this Act, such members of the  
46 board serving from those former districts shall be deemed to be serving from and  
47 representing their respective districts as newly described under this Act."

48 **SECTION 2.**

49 The provisions of this Act relating to and necessary for the regular election in 2022 of  
50 members of the Board of Education of Taliaferro County shall become effective upon its  
51 approval by the Governor or upon its becoming law without such approval. The remaining  
52 provisions of this Act shall otherwise become effective January 1, 2023.

53 **SECTION 3.**

54 All laws and parts of laws in conflict with this Act are repealed.
