

House Bill 1172 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act to create a board of commissioners of roads and revenues for the county  
2 of Monroe, approved August 19, 1907 (Ga. L. 1907, p. 318), as amended, so as to change the  
3 description of the districts from which members of the commission are elected; to provide  
4 for definitions and inclusions; to provide for the continuation in office of current members;  
5 to provide for effective dates; to provide for related matters; to repeal conflicting laws; and  
6 for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act to create a board of commissioners of roads and revenues for the county of Monroe,  
10 approved August 19, 1907 (Ga. L. 1907, p. 318), as amended, is amended by revising  
11 subsections (a), (b), and (d) of Section 1 as follows:

12 "(a) There is created the Board of Commissioners of Monroe County which shall conduct  
13 and administer the county affairs of Monroe County. The board shall be composed of five  
14 members. For the purpose of electing members of the board, Monroe County shall be  
15 divided into four commissioner districts which shall be and correspond to those four

16 numbered districts described in Appendix A attached to and made a part of this Act and  
17 further identified as 'User: Monroe CC Plan Name: MonroeCC-2022 Plan Type: Local'.

18 (b)(1) For the purposes of such plan:

19 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
20 provided in the report of the Bureau of the Census for the United States decennial  
21 census of 2020 for the State of Georgia. The separate numeric designations in a district  
22 description which are underneath a VTD heading shall mean and describe individual  
23 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
24 United States decennial census of 2020 for the State of Georgia; and

25 (B) Except as otherwise provided in the description of any district, whenever the  
26 description of any district refers to a named city, it shall mean the geographical  
27 boundaries of that city as shown on the census maps for the United States decennial  
28 census of 2020 for the State of Georgia.

29 (2) Any part of Monroe County which is not included in any district described in  
30 subsection (a) of this section shall be included within that district contiguous to such part  
31 which contains the least population according to the United States decennial census  
32 of 2020 for the State of Georgia.

33 (3) Any part of Monroe County which is described in subsection (a) of this section as  
34 being included in a particular district shall nevertheless not be included within such  
35 district if such part is not contiguous to such district. Such noncontiguous part shall  
36 instead be included within that district contiguous to such part which contains the least  
37 population according to the United States decennial census of 2020 for the State of  
38 Georgia."

39 "(d) Commissioner Districts 1, 2, 3, and 4, as they exist immediately prior to the effective  
40 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,  
41 respectively, but as newly described under this Act, and on and after the effective date of  
42 this Act, such members of the board serving from those former commissioner districts shall

43 be deemed to be serving from and representing their respective districts as newly described  
44 under this Act.”

45 **SECTION 2.**

46 Those members of the Board of Commissioners of Monroe County who are serving as such  
47 on the effective date of this Act and any person selected to fill a vacancy in any such office  
48 shall continue to serve as such members until the regular expiration of their respective terms  
49 of office and upon the election and qualification of their respective successors.

50 **SECTION 3.**

51 The provisions of this Act necessary to conduct elections for the members of the Board of  
52 Commissioners of Monroe County in 2022 shall become effective upon the approval of this  
53 Act by the Governor or upon its becoming law without such approval. The remaining  
54 provisions of this Act shall become effective on January 1, 2023.

55 **SECTION 4.**

56 All laws and parts of laws in conflict with this Act are repealed.
