A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating the Board of Commissioners of Lamar County, approved
- 2 March 8, 1943 (Ga. L. 1943, p. 1066), as amended, particularly by an Act approved
- 3 March 13, 2012 (Ga. L. 2012, p. 4422), so as to reconstitute the board of commissioners; to
- 4 change the description of the commissioner districts; to provide for definitions and
- 5 inclusions; to provide for continuation in office of current members; to provide for related
- 6 matters; to provide for effective dates; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act creating the Board of Commissioners of Lamar County, approved March 8, 1943
- 10 (Ga. L. 1943, p. 1066), as amended, particularly by an Act approved March 13, 2012
- 11 (Ga. L. 2012, p. 4422), is amended by revising subsections (b) and (c) of Section 2 as
- 12 follows:

- 13 "(b) For purposes of electing members of the board of commissioners, other than the
- chairperson, Lamar County shall be divided into four commissioner districts. One member
- of the board shall be elected from each such district. Commissioner districts 1 through 4
- shall be and correspond to those four numbered districts described in Appendix A attached

17 to and made a part of this Act and further identified as 'User: Lamar Co.

- 18 Plan Name: LamarCCSB-2022 Plan Type: Local'.
- 19 (c) For the purposes of such plan:
- 20 (1) The term 'VTD' shall mean and describe the same geographical boundaries as
- 21 provided in the report of the Bureau of the Census for the United States decennial census
- of 2020 for the State of Georgia.
- 23 (2) The separate numeric designations in a district description which are underneath a
- VTD heading shall mean and describe individual Blocks within a VTD as provided in the
- 25 report of the Bureau of the Census for the United States decennial census of 2020 for the
- State of Georgia. Any part of Lamar County which is not included in any district
- described in subsection (b) of this section shall be included within that district contiguous
- 28 to such part which contains the least population according to the United States decennial
- census of 2020 for the State of Georgia.
- 30 (3) Any part of Lamar County which is described in subsection (b) of this section as
- being included in a particular district shall nevertheless not be included within such
- district if such part is not contiguous to such district. Such noncontiguous part shall
- instead be included within that district contiguous to such part which contains the least
- population according to the United States decennial census of 2020 for the State of
- 35 Georgia.
- 36 (4) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- 38 boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia."

40 **SECTION 2.**

- 41 (a) Those members of the Board of Commissioners of Lamar County who are serving as
- 42 such on the effective date of this Act and any person selected to fill a vacancy in any such

office shall continue to serve as such members until the regular expiration of their respective

- 44 terms of office and upon the election and qualification of their respective successors.
- 45 (b) Commissioner districts 1 through 4, as they exist immediately prior to the effective date
- 46 of this Act, shall continue to be designated as commissioner districts 1 through 4,
- 47 respectively, but as newly described under this Act, and on and after the effective date of this
- 48 Act, such members of the board serving from those former commissioner districts shall be
- 49 deemed to be serving from and representing their respective districts as newly described
- 50 under this Act.

51 SECTION 3.

- 52 The provisions of this Act necessary to conduct elections for the members of the Board of
- 53 Commissioners of Lamar County in 2022 shall become effective upon the approval of this
- 54 Act by the Governor or upon its becoming law without such approval. The remaining
- provisions of this Act shall become effective on January 1, 2023.

SECTION 4.

57 All laws and parts of laws in conflict with this Act are repealed.
