

House Bill 1230 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act providing for the election of the members of the Lamar County Board of  
2 Education, approved March 30, 1971 (Ga. L. 1971, p. 2710), as amended, particularly by an  
3 Act approved March 13, 2012 (Ga. L. 2012, p. 4416), so as to reconstitute the board of  
4 education; to change the description of the education districts; to provide for definitions and  
5 inclusions; to provide for continuation in office of current members; to provide for related  
6 matters; to provide for effective dates; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act providing for the election of the members of the Lamar County Board of Education,  
10 approved March 30, 1971 (Ga. L. 1971, p. 2710), as amended, particularly by an Act  
11 approved March 13, 2012 (Ga. L. 2012, p. 4416), is amended by revising Section 2 as  
12 follows:

13 "SECTION 2.

14 (a) Those members of the Board of Education of Lamar County who are serving as such  
15 on the effective date of this Act and any person selected to fill a vacancy in any such office

16 shall continue to serve as such members until the regular expiration of their respective  
17 terms of office and upon the election and qualification of their respective successors. On  
18 and after the effective date of this Act, the Lamar County Board of Education shall consist  
19 of five members, all of whom shall be elected from education districts described in  
20 subsection (b) of this section except for the member who is elected at large as provided in  
21 Section 3 of this Act.

22 (b) For purposes of electing members of the board of education, other than the member  
23 elected at large, the Lamar County School District shall be divided into four education  
24 districts. One member of the board shall be elected from each district. Districts 1, 2, 3, and  
25 4 shall be and correspond to those four numbered districts described in Appendix A  
26 attached to and made a part of this Act and further identified as 'User: Lamar Co.  
27 Plan Name: LamarCCSB-2022 Plan Type: Local'.

28 (c) For the purposes of such plan:

29 (1) The term 'VTD' shall mean and describe the same geographical boundaries as  
30 provided in the report of the Bureau of the Census for the United States decennial census  
31 of 2020 for the State of Georgia.

32 (2) The separate numeric designations in a district description which are underneath a  
33 VTD heading shall mean and describe individual Blocks within a VTD as provided in the  
34 report of the Bureau of the Census for the United States decennial census for 2020 for the  
35 State of Georgia. Any part of the Lamar County School District which is not included  
36 in any district described in subsection (b) of this section shall be included within that  
37 district contiguous to such part which contains the least population according to the  
38 United States decennial census of 2020 for the State of Georgia.

39 (3) Any part of the Lamar County School District which is described in subsection (b)  
40 of this section as being included in a particular district shall nevertheless not be included  
41 within such district if such part is not contiguous to such district. Such noncontiguous  
42 part shall instead be included within that district contiguous to such part which contains

43 the least population according to the United States decennial census of 2020 for the State  
44 of Georgia.

45 (4) Except as otherwise provided in the description of any district, whenever the  
46 description of any district refers to a named city, it shall mean the geographical  
47 boundaries of that city as shown on the census maps for the United States decennial  
48 census of 2020 for the State of Georgia."

49 **SECTION 2.**

50 Districts 1, 2, 3, and 4, as they exist immediately prior to the effective date of this Act, shall  
51 continue to be designated as Districts 1, 2, 3, and 4, respectively, but as newly described  
52 under this Act, and on and after the effective date of this Act, such members of the board  
53 serving from those former districts shall be deemed to be serving from and representing their  
54 respective districts as newly described under this Act.

55 **SECTION 3.**

56 The provisions of this Act necessary to conduct elections for the members of the Board of  
57 Education of Lamar County in 2022 shall become effective upon the approval of this Act by  
58 the Governor or upon its becoming law without such approval. The remaining provisions  
59 of this Act shall become effective on January 1, 2023.

60 **SECTION 4.**

61 All laws and parts of laws in conflict with this Act are repealed.
