

House Bill 1236 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act creating the Board of Commissioners of Irwin County, approved  
2 February 16, 1933 (Ga. L. 1933, p. 571), as amended, particularly by an Act approved  
3 March 5, 2012 (Ga. L. 2012, p. 4058), so as to change the description of the commissioner  
4 districts; to provide for definitions and inclusions; to provide for continuation in office of  
5 current members; to provide for related matters; to provide for effective dates; to repeal  
6 conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act creating the Board of Commissioners of Irwin County, approved February 16, 1933  
10 (Ga. L. 1933, p. 571), as amended, particularly by an Act approved March 5, 2012 (Ga. L.  
11 2012, p. 4058), is amended by revising subsections (d) and (e) of Section 1 as follows:

12 "(d) For the purposes of electing members of the board other than the chairperson, Irwin  
13 County shall be divided into four commissioner districts, and those districts shall be and  
14 correspond to those four numbered districts described in Appendix A attached to and made  
15 a part of this Act and further identified as 'User: Irwin CC Plan Name: IrwinCC-2022 Plan  
16 Type: Local'.

17 (e)(1) For the purposes of such plan:

18 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
19 provided in the report of the Bureau of the Census for the United States decennial  
20 census of 2020 for the State of Georgia. The separate numeric designations in a district  
21 description which are underneath a VTD heading shall mean and describe individual  
22 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
23 United States decennial census of 2020 for the State of Georgia; and

24 (B) Except as otherwise provided in the description of any district, whenever the  
25 description of any district refers to a named city, it shall mean the geographical  
26 boundaries of that city as shown on the census maps for the United States decennial  
27 census of 2020 for the State of Georgia.

28 (2) Any part of Irwin County which is not included in any district described in subsection  
29 (d) of this section shall be included within that district contiguous to such part which  
30 contains the least population according to the United States decennial census of 2020 for  
31 the State of Georgia.

32 (3) Any part of Irwin County which is described in subsection (d) of this section as being  
33 included in a particular district shall nevertheless not be included within such district if  
34 such part is not contiguous to such district. Such noncontiguous part shall instead be  
35 included within that district contiguous to such part which contains the least population  
36 according to the United States decennial census of 2020 for the State of Georgia."

37 **SECTION 2.**

38 (a) Those members of the Board of Commissioners of Irwin County who are serving as such  
39 on the effective date of this Act and any person selected to fill a vacancy in any such office  
40 shall continue to serve as such members until the regular expiration of their respective terms  
41 of office and upon the election and qualification of their respective successors.

42 (b) Commissioner Districts 1, 2, 3, and 4, as they exist immediately prior to the effective  
43 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,  
44 respectively, but as newly described under this Act, and on and after the effective date of this  
45 Act, such members of the board serving from those former commissioner districts shall be  
46 deemed to be serving from and representing their respective districts as newly described  
47 under this Act.

48 **SECTION 3.**

49 The provisions of this Act necessary to conduct elections for the members of the Board of  
50 Commissioners of Irwin County in 2022 shall become effective upon the approval of this Act  
51 by the Governor or upon its becoming law without such approval. The remaining provisions  
52 of this Act shall become effective on January 1, 2023.

53 **SECTION 4.**

54 All laws and parts of laws in conflict with this Act are repealed.
