

House Bill 1247 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act providing for the Board of Education of Camden County, approved March  
2 30, 1987 (Ga. L. 1987, p. 4943), as amended, particularly by an Act approved March 5, 2012  
3 (Ga. L. 2012, p. 3955), so as to provide new district boundaries; to provide for definitions  
4 and inclusions; to provide for continuation in office of current members; to provide for  
5 related matters; to provide for effective dates; to repeal conflicting laws; and for other  
6 purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act providing for the Board of Education of Camden County, approved March 30, 1987  
10 (Ga. L. 1987, p. 4943), as amended, particularly by an Act approved March 5, 2012 (Ga. L.  
11 2012, p. 3955), is amended by revising Section 2 as follows:

12 "SECTION 2.

13 (a) Those members of the Board of Education of Camden County who are serving as such  
14 on the effective date of this Act and any person selected to fill a vacancy in any such office

15 shall continue to serve as such members until the regular expiration of their respective  
16 terms of office and upon the election and qualification of their respective successors.

17 (b) For purposes of electing members of the board of education, the Camden County  
18 School District shall be divided into five education districts. One member of the board  
19 shall be elected from each such district. Districts 1, 2, 3, 4, and 5 shall be and correspond  
20 to those five numbered districts described in Appendix A attached to and made a part of  
21 this Act and further identified as 'User: Camden Co. Plan Name: CamdenCCSB-2022 Plan  
22 Type: Local'.

23 (c)(1) For the purposes of such plan:

24 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
25 provided in the report of the Bureau of the Census for the United States decennial  
26 census of 2020 for the State of Georgia. The separate numeric designations in a district  
27 description which are underneath a VTD heading shall mean and describe individual  
28 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
29 United States decennial census for 2020 for the State of Georgia; and

30 (B) Except as otherwise provided in the description of any district, whenever the  
31 description of any district refers to a named city, it shall mean the geographical  
32 boundaries of that city as shown on the census maps for the United States decennial  
33 census of 2020 for the State of Georgia.

34 (2) Any part of the Camden County School District which is not included in any district  
35 described in subsection (b) of this section shall be included within that district contiguous  
36 to such part which contains the least population according to the United States decennial  
37 census of 2020 for the State of Georgia.

38 (3) Any part of the Camden County School District which is described in subsection (b)  
39 of this section as being included in a particular district shall nevertheless not be included  
40 within such district if such part is not contiguous to such district. Such noncontiguous  
41 part shall instead be included within that district contiguous to such part which contains

42 the least population according to the United States decennial census of 2020 for the State  
43 of Georgia.

44 (d) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this  
45 Act, shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly  
46 described under this Act, and on and after the effective date of this Act, such members of  
47 the board serving from those former districts shall be deemed to be serving from and  
48 representing their respective districts as newly described under this Act.”

49 **SECTION 2.**

50 The provisions of this Act necessary to conduct elections for the members of the Board of  
51 Education of Camden County in 2022 shall become effective upon the approval of this Act  
52 by the Governor or upon its becoming law without such approval. The remaining provisions  
53 of this Act shall become effective on January 1, 2023.

54 **SECTION 3.**

55 All laws and parts of laws in conflict with this Act are repealed.
