A BILL TO BE ENTITLED AN ACT

1 To amend an Act providing for the election of the Board of Commissioners of Schley

- 2 County, approved February 5, 1951 (Ga. L. 1951, p. 2229), as amended, so as to change the
- 3 description of the commissioner districts; to provide for definitions and inclusions; to provide
- 4 for continuation in office of current members; to provide for effective dates; to repeal
- 5 conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 SECTION 1.

- 8 An Act providing for the election of the Board of Commissioners of Schley County,
- 9 approved February 5, 1951 (Ga. L. 1951, p. 2229), as amended, is amended by revising
- 10 subsection (a) of Section 1 as follows:
- 11 "(a)(1) For purposes of electing members of the board of commissioners, other than the
- chairperson, Schley County is divided into four commissioner districts. One member of
- the board shall be elected from each such district. The four commissioner districts shall
- be and correspond to those four numbered districts described in Appendix A attached to
- and made a part of this Act and further identified as 'User: Schley Co. Plan Name:
- SchleyCCSB-2022 Plan Type: Local'. The fifth member of the board shall be the

17 chairperson and shall be elected at large from the entire county. Such position shall be 18 designated as Commissioner District 5.

(2) For the purposes of such plan:

- 20 (A) The term 'VTD' shall mean and describe the same geographical boundaries as 21 provided in the report of the Bureau of the Census for the United States decennial 22 census of 2020 for the State of Georgia. The separate numeric designations in a district 23 description which are underneath a VTD heading shall mean and describe individual 24 Blocks within a VTD as provided in the report of the Bureau of the Census for the 25 United States decennial census of 2020 for the State of Georgia; and
 - (B) Except as otherwise provided in the description of any district, whenever the description of any district refers to a named city, it shall mean the geographical boundaries of that city as shown on the census maps for the United States decennial census of 2020 for the State of Georgia.
 - (3) Any part of Schley County which is not included in any district described in paragraph (1) of this subsection shall be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia.
 - (4) Any part of Schley County which is described in paragraph (1) of this subsection as being included in a particular district shall nevertheless not be included within such district if such part is not contiguous to such district. Such noncontiguous part shall instead be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia."

40 SECTION 2.

41 (a) Those members of the board of commissioners who are serving as such on the effective 42 date of this Act and any person selected to fill a vacancy in any such office shall continue to

43 serve as such members until the regular expiration of their respective terms of office and

- 44 upon the election and qualification of their respective successors.
- 45 (b) Commissioner Districts 1, 2, 3, and 4, as they existed immediately prior to the effective
- 46 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,
- 47 respectively, but as newly described under this Act, and on and after the effective date of this
- 48 Act, such members of the board serving from those former commissioner districts shall be
- 49 deemed to be serving from and representing their respective districts as newly described
- 50 under this Act.

51 SECTION 3.

- 52 The provisions of this Act necessary to conduct elections for the members of the Board of
- 53 Commissioners of Schley County in 2022 shall become effective upon the approval of this
- 54 Act by the Governor or upon its becoming law without such approval. The remaining
- provisions of this Act shall become effective on January 1, 2023.

SECTION 4.

57 All laws and parts of laws in conflict with this Act are repealed.
