A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating a Board of Commissioners of Terrell County, approved
- 2 February 28, 1966 (Ga. L. 1966, p. 2610), as amended, particularly by an Act approved
- 3 February 27, 2012 (Ga. L. 2012, p. 3683), so as to revise the districts for the election of
- 4 members of the board of commissioners; to provide for definitions and inclusions; to provide
- 5 for continuation in office of current members; to provide for related matters; to provide
- 6 effective dates; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act creating a Board of Commissioners of Terrell County, approved February 28, 1966
- 10 (Ga. L. 1966, p. 2610), as amended, particularly by an Act approved February 27, 2012
- 11 (Ga. L. 2012, p. 3683), is amended by revising subsections (a) and (b) of Section 1 as
- 12 follows:

- 13 "(a) There is created a board of commissioners of roads and revenues for Terrell County,
- to be composed of a chairperson and four commissioners. The chairperson shall be elected
- 15 from the county at large by a majority of the voters residing within the county voting in the
- 16 election. For the purpose of electing the board of commissioners other than the

17 chairperson, Terrell County is divided into four commissioner districts. Commissioner

- Districts 1 through 4 shall be and correspond to those four numbered districts described in
- 19 Appendix A attached to and made a part of this Act and further identified as 'User: Terrell
- 20 CC Plan Name: TerrellCC-2022 Plan Type: Local'.
- 21 (b)(1) For the purposes of such plan:
- 22 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial
- census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a 'VTD' heading shall mean and describe individual
- 26 Blocks within a VTD as provided in the report of the Bureau of the Census for the
- United States decennial census of 2020 for the State of Georgia; and
- 28 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 32 (2) Any part of Terrell County which is not included in any district described in
- subsection (a) of this section shall be included within that district contiguous to such part
- which contains the least population according to the United States decennial census of
- 35 2020 for the State of Georgia.
- 36 (3) Any part of Terrell County which is described in subsection (a) of this section as
- being included in a particular district shall nevertheless not be included within such
- district if such part is not contiguous to such district. Such noncontiguous part shall
- instead be included within that district contiguous to such part which contains the least
- 40 population according to the United States decennial census of 2020 for the State of
- 41 Georgia."

42 SECTION 2.

- 43 (a) Those members of the Board of Commissioners of Terrell County who are serving as
- such on the effective date of this Act and any person selected to fill a vacancy in any such
- office shall continue to serve as such members until the regular expiration of their respective
- 46 terms of office and upon the election and qualification of their respective successors.
- 47 (b) Commissioner Districts 1 through 4, as they exist immediately prior to the effective date
- 48 of this Act, shall continue to be designated as Commissioner Districts 1 through 4,
- 49 respectively, but as newly described under this Act, and on and after the effective date of this
- Act, such members of the board serving from those former commissioner districts shall be
- 51 deemed to be serving from and representing their respective districts as newly described
- 52 under this Act.

53 SECTION 3.

- 54 The provisions of this Act necessary to conduct elections for the members of the board in
- 55 2022 shall become effective upon the approval of this Act by the Governor or upon its
- 56 becoming law without such approval. The remaining provisions of this Act shall become
- 57 effective January 1, 2023.

58 SECTION 4.

59 All laws and parts of laws in conflict with this Act are repealed.
