## A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act changing the method of selecting the members of the Board of Education
- of Miller County, approved March 21, 1968 (Ga. L. 1968, p. 2529), as amended, particularly
- 3 by an Act approved February 28, 2020 (Ga. L. 2020, p. 3501), so as to provide new district
- 4 boundaries; to provide for definitions and inclusions; to provide for continuation in office of
- 5 current members; to provide for related matters; to provide for effective dates; to repeal
- 6 conflicting laws; and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act changing the method of selecting the members of the Board of Education of Miller
- 10 County, approved March 21, 1968 (Ga. L. 1968, p. 2529), as amended, particularly by an Act
- approved February 28, 2020 (Ga. L. 2020, p. 3501), is amended by revising subsections (a)
- 12 and (b) of Section 1 as follows:

- 13 "(a) The Board of Education of Miller County shall consist of five members. For purposes
- of electing members of the board of education, the Miller County School District shall be
- divided into five education districts. Districts 1, 2, 3, 4, and 5 shall be and correspond to
- those five numbered districts described in Appendix A attached to and made a part of this

17 Act and further identified as 'User: Miller Co. Plan Name: Miller CCSB-2022 Plan Type:

- 18 Local'.
- 19 (b)(1) For the purposes of such plan:
- 20 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- 21 provided in the report of the Bureau of the Census for the United States decennial
- census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- 24 Blocks within a VTD as provided in the report of the Bureau of the Census for the
- United States decennial census for 2020 for the State of Georgia; and
- 26 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 30 (2) Any part of the Miller County School District which is not included in any district
- described in subsection (a) of this section shall be included within that district contiguous
- 32 to such part which contains the least population according to the United States decennial
- census of 2020 for the State of Georgia.
- 34 (3) Any part of the Miller County School District which is described in subsection (a)
- of this section as being included in a particular district shall nevertheless not be included
- within such district if such part is not contiguous to such district. Such noncontiguous
- part shall instead be included within that district contiguous to such part which contains
- the least population according to the United States decennial census of 2020 for the State
- 39 of Georgia."

40 SECTION 2.

- 41 (a) Those members of the Board of Education of Miller County who are serving as such on
- 42 the effective date of this Act and any person selected to fill a vacancy in any such office shall

43 continue to serve as such members until the regular expiration of their respective terms of

- 44 office and upon the election and qualification of their respective successors.
- 45 (b) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act,
- shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly
- described under this Act, and on and after the effective date of this Act, such members of the
- 48 board serving from those former districts shall be deemed to be serving from and
- 49 representing their respective districts as newly described under this Act.

SECTION 3.

- 51 The provisions of this Act necessary to conduct elections for the members of the Board of
- 52 Education of Miller County in 2022 shall become effective upon the approval of this Act by
- 53 the Governor or upon its becoming law without such approval. The remaining provisions
- of this Act shall become effective on January 1, 2023.

SECTION 4.

All laws and parts of laws in conflict with this Act are repealed.
