

House Bill 1263 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act creating the Board of Commissioners of Miller County, approved March
2 29, 1983 (Ga. L. 1983, p. 4594), as amended, particularly by an Act approved February 28,
3 2020 (Ga. L. 2020, p. 3505), to change the description of the commissioner districts; to
4 provide for definitions and inclusions; to provide for continuation in office of current
5 members; to provide for effective dates; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act creating the Board of Commissioners of Miller County, approved March 29, 1983
9 (Ga. L. 1983, p. 4594), as amended, particularly by an Act approved February 28, 2020
10 (Ga. L. 2020, p. 3505), is amended by revising subsections (a) and (b) of Section 2 as
11 follows:

12 "(a) The Board of Commissioners of Miller County shall consist of five members. For
13 purposes of electing members of the board of commissioners, Miller County shall be
14 divided into five commissioner districts. Commissioner districts 1, 2, 3, 4, and 5 shall be
15 and correspond to those five numbered districts described in Appendix A attached to and

16 made a part of this Act and further identified as 'User: Miller Co. Plan Name:
17 MillerCCSB-2022 Plan Type: Local'.

18 (b)(1) For the purposes of such plan:

19 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
20 provided in the report of the Bureau of the Census for the United States decennial
21 census of 2020 for the State of Georgia. The separate numeric designations in a district
22 description which are underneath a VTD heading shall mean and describe individual
23 Blocks within a VTD as provided in the report of the Bureau of the Census for the
24 United States decennial census of 2020 for the State of Georgia; and

25 (B) Except as otherwise provided in the description of any district, whenever the
26 description of any district refers to a named city, it shall mean the geographical
27 boundaries of that city as shown on the census maps for the United States decennial
28 census of 2020 for the State of Georgia.

29 (2) Any part of Miller County which is not included in any district described in
30 subsection (a) of this section shall be included within that district contiguous to such part
31 which contains the least population according to the United States decennial census of
32 2020 for the State of Georgia.

33 (3) Any part of Miller County which is described in subsection (a) of this section as
34 being included in a particular district shall nevertheless not be included within such
35 district if such part is not contiguous to such district. Such noncontiguous part shall
36 instead be included within that district contiguous to such part which contains the least
37 population according to the United States decennial census of 2020 for the State of
38 Georgia."

39 **SECTION 2.**

40 (a) Those members of the Board of Commissioners of Miller County who are serving as
41 such on the effective date of this Act and any person selected to fill a vacancy in any such

42 office shall continue to serve as such members until the regular expiration of their respective
43 terms of office and upon the election and qualification of their respective successors.

44 (b) Commissioner districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective
45 date of this Act, shall continue to be designated as commissioner districts 1, 2, 3, 4, and 5,
46 respectively, but as newly described under this Act, and on and after the effective date of this
47 Act, such members of the board serving from those former commissioner districts shall be
48 deemed to be serving from and representing their respective districts as newly described
49 under this Act.

50 **SECTION 3.**

51 The provisions of this Act necessary to conduct elections for the members of the Board of
52 Commissioners of Miller County in 2022 shall become effective upon the approval of this
53 Act by the Governor or upon its becoming law without such approval. The remaining
54 provisions of this Act shall become effective on January 1, 2023.

55 **SECTION 4.**

56 All laws and parts of laws in conflict with this Act are repealed.
