

House Bill 1265 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act creating the Clayton County Board of Commissioners, approved
2 February 8, 1955 (Ga. L. 1955, p. 2064), as amended, so as to change the description of the
3 commissioner districts; to provide for definitions and inclusions; to provide for continuation
4 in office of current members; to provide for related matters; to provide for effective dates;
5 to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act creating the Clayton County Board of Commissioners, approved February 8, 1955
9 (Ga. L. 1955, p. 2064), as amended, is amended by revising subsection (b) of Section 2 as
10 follows:

11 "(b)(1) For the purpose of electing commissioners, Clayton County is divided into four
12 commissioner districts which shall be and correspond to those four numbered districts
13 described in Appendix A attached to and made a part of this Act and further identified as
14 'User: Clayton CC Plan Name: ClaytonCC-2022 Plan Type: Local'.

15 (2) For the purposes of such plan:

16 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
17 provided in the report of the Bureau of the Census for the United States decennial
18 census of 2020 for the State of Georgia. The separate numeric designations in a district
19 description which are underneath a VTD heading shall mean and describe individual
20 Blocks within a VTD as provided in the report of the Bureau of the Census for the
21 United States decennial census of 2020 for the State of Georgia; and

22 (B) Except as otherwise provided in the description of any district, whenever the
23 description of any district refers to a named city, it shall mean the geographical
24 boundaries of that city as shown on the census maps for the United States decennial
25 census of 2020 for the State of Georgia.

26 (3) Any part of Clayton County which is not included in any district described in
27 paragraph (1) of this subsection shall be included within that district contiguous to such
28 part which contains the least population according to the United States decennial census
29 of 2020 for the State of Georgia.

30 (4) Any part of Clayton County which is described in paragraph (1) of this subsection
31 as being included in a particular district shall nevertheless not be included within such
32 district if such part is not contiguous to such district. Such noncontiguous part shall
33 instead be included within that district contiguous to such part which contains the least
34 population according to the United States decennial census of 2020 for the State of
35 Georgia."

36 **SECTION 2.**

37 (a) Those members of the Board of Commissioners of Clayton County who are serving as
38 such on the effective date of this Act and any person selected to fill a vacancy in any such
39 office shall continue to serve as such members until the regular expiration of their respective
40 terms of office and upon the election and qualification of their respective successors.

41 (b) Commissioner Districts 1, 2, 3, and 4, as they exist immediately prior to the effective
42 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,
43 respectively, but as newly described under this Act, and on and after the effective date of this
44 Act, such members of the board serving from those former commissioner districts shall be
45 deemed to be serving from and representing their respective districts as newly described
46 under this Act.

47 **SECTION 3.**

48 The provisions of this Act necessary to conduct elections for the members of the Board of
49 Commissioners of Clayton County in 2022 shall become effective upon the approval of this
50 Act by the Governor or upon its becoming law without such approval. The remaining
51 provisions of this Act shall become effective on January 1, 2023.

52 **SECTION 4.**

53 All laws and parts of laws in conflict with this Act are repealed.
