A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating the Board of Commissioners of Randolph County, approved
- 2 February 13, 1935 (Ga. L. 1935, p. 778), as amended, particularly by an Act approved
- 3 September 21, 2011 (Ga. L. 2011 Ex. Sess., p. 397), so as to change the description of the
- 4 commissioner districts; to provide for definitions and inclusions; to provide for continuation
- 5 in office of current members; to provide for related matters; to provide for effective dates;
- 6 to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act creating the Board of Commissioners of Randolph County, approved February 13,
- 10 1935 (Ga. L. 1935, p. 778), as amended, particularly by an Act approved September 21, 2011
- 11 (Ga. L. 2011 Ex. Sess., p. 397), is amended by revising Section 3 as follows:
- 12 "SECTION 3.
- 13 For the purposes of electing members of the board of commissioners, Randolph County shall
- 14 be divided into five commissioner districts. The five commissioner districts shall be and
- 15 correspond to those five numbered districts described in Appendix A attached to and made

16 a part of this Act and further identified as 'User: Randolph Co. Plan Name:

17 RandolphCCSB-2022 Plan Type: Local'."

18 SECTION 2.

19 Said Act is further amended by revising Section 4 as follows:

20 "SECTION 4.

- 21 (a) For the purposes of such plan:
- 22 (1) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial census
- of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- 26 Blocks within a VTD as provided in the report of the Bureau of the Census for the United
- 27 States decennial census of 2020 for the State of Georgia; and
- 28 (2) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- 30 boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 32 (b) Any part of Randolph County which is not included in any district described in
- 33 Section 3 of this Act shall be included within that district contiguous to such part which
- contains the least population according to the United States decennial census of 2020 for
- 35 the State of Georgia.
- 36 (c) Any part of Randolph County which is described in Section 3 of this Act as being
- included in a particular district shall nevertheless not be included within such district if
- such part is not contiguous to such district. Such noncontiguous part shall instead be
- included within that district contiguous to such part which contains the least population
- 40 according to the United States decennial census of 2020 for the State of Georgia."

41 SECTION 3.

- 42 (a) Those members of the Board of Commissioners of Randolph County who are serving as
- 43 such on the effective date of this Act and any person selected to fill a vacancy in any such
- office shall continue to serve as such members until the regular expiration of their respective
- 45 terms of office and upon the election and qualification of their respective successors.
- 46 (b) Commissioner Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective
- date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, 4, and 5,
- 48 respectively, but as newly described under this Act, and on and after the effective date of this
- 49 Act, such members of the board serving from those former commissioner districts shall be
- 50 deemed to be serving from and representing their respective districts as newly described
- 51 under this Act.

52 SECTION 4.

- 53 The provisions of this Act necessary to conduct elections for the members of the Board of
- 54 Commissioners of Randolph County in 2022 shall become effective upon the approval of this
- 55 Act by the Governor or upon its becoming law without such approval. The remaining
- 56 provisions of this Act shall become effective on January 1, 2023.

57 SECTION 5.

All laws and parts of laws in conflict with this Act are repealed.
