A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act reconstituting the Board of Education of Atkinson County, approved
- 2 April 5, 1993 (Ga. L. 1993, p. 4771), as amended, particularly by an Act approved March 13,
- 3 2012 (Ga. L. 2012, p. 4400), so as to change the description of the education districts; to
- 4 provide for definitions and inclusions; to provide for continuation in office of current
- 5 members; to provide for related matters; to provide for an effective date; to repeal conflicting
- 6 laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act reconstituting the Board of Education of Atkinson County, approved April 5, 1993
- 10 (Ga. L. 1993, p. 4771), as amended, particularly by an Act approved March 13, 2012 (Ga.
- 11 L. 2012, p. 4400), is amended by revising Section 2 as follows:
- 12 "SECTION 2.
- 13 (a) The Board of Education of Atkinson County shall consist of five members, all of whom
- shall be elected from education districts as described in subsection (b) of this section.

15 (b) For purposes of electing members of the board of education, the Atkinson County

- School District is divided into five education districts. One member of the board shall be
- 17 elected from each such district. The five education districts shall be and correspond to
- those five numbered districts described in Appendix A attached to and made a part of this
- 19 Act and further identified as 'User: Atkinson Co. Plan Name: AtkinsonCCSB-2022 Plan
- 20 Type: Local'.
- 21 (c)(1) For the purposes of such plan:
- 22 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial
- census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- 26 Blocks within a VTD as provided in the report of the Bureau of the Census for the
- 27 United States decennial census of 2020 for the State of Georgia; and
- 28 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- 30 boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 32 (2) Any part of the Atkinson County School District which is not included in any district
- described in subsection (b) of this section shall be included within that district contiguous
- to such part which contains the least population according to the United States decennial
- census of 2020 for the State of Georgia.
- 36 (3) Any part of the Atkinson County School District which is described in subsection (b)
- of this section as being included in a particular district shall nevertheless not be included
- within such district if such part is not contiguous to such district. Such noncontiguous
- part shall instead be included within that district contiguous to such part which contains
- 40 the least population according to the United States decennial census of 2020 for the State
- 41 of Georgia."

42 SECTION 2.

- 43 (a) Those members of the Board of Education of Atkinson County who are serving as such
- on the effective date of this Act and any person selected to fill a vacancy in any such office
- 45 shall continue to serve as such members until the regular expiration of their respective terms
- of office and upon the election and qualification of their respective successors.
- 47 (b) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act,
- 48 shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly
- 49 described under this Act, and on and after the effective date of this Act, such members of the
- 50 board serving from those former districts shall be deemed to be serving from and
- 51 representing their respective districts as newly described under this Act.

52 SECTION 3.

53 This Act shall become effective on January 1, 2023.

SECTION 4.

All laws and parts of laws in conflict with this Act are repealed.
