A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act to provide a new charter for the City of Glennville, approved May 8, 2018
- 2 (Ga. L. 2018, p. 4003), so as to change the description of the wards; to provide for definitions
- 3 and inclusions; to provide for the continuation in office of current members; to provide for
- 4 related matters; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 SECTION 1.

- 7 An Act to provide a new charter for the City of Glennville, approved May 8, 2018
- 8 (Ga. L. 2018, p. 4003), is amended by revising subsection (e) of Section 4 as follows:
- 9 "(e)(1) For the purpose of electing councilmembers, the City of Glennville shall be
- divided into four wards. Those wards shall be and correspond to those four numbered
- districts described in Appendix A attached to and made a part of this Act and further
- identified as 'User: City of Glennville Plan Name: GlennvilleCC-2022 Plan Type: Local'.
- 13 (2) For the purposes of such plan:

- 14 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial
- 16 census of 2020 for the State of Georgia. The separate numeric designations in a district

description which are underneath a VTD heading shall mean and describe individual
Blocks within a VTD as provided in the report of the Bureau of the Census for the
United States decennial census of 2020 for the State of Georgia; and

- (B) Except as otherwise provided in the description of any district, whenever the description of any district refers to a named city, it shall mean the geographical boundaries of that city as shown on the census maps for the United States decennial census of 2020 for the State of Georgia.
- (3) Any part of the City of Glennville which is not included in any district described in paragraph (1) of this subsection shall be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia.
- (4) Any part of the City of Glennville which is described in paragraph (1) of this subsection as being included in a particular district shall nevertheless not be included within such district if such part is not contiguous to such district. Such noncontiguous part shall instead be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia."

34 SECTION 2.

35 (a) Those members of the city council of the City of Glennville who are serving as such 36 immediately prior to the effective date of this Act and any person selected to fill a vacancy 37 in any such office shall continue to serve as such members until the regular expiration of 38 their respective terms of office and upon the election and qualification of their respective

39 successors.

40 (b) Wards 1, 2, 3, and 4, as they exist immediately prior to the effective date of this Act,

shall continue to be designated as Wards 1, 2, 3, and 4, but as newly described under this

42 Act, and on and after the effective date of this Act, such members of the city council serving

43 from those former council districts shall be deemed to be serving from and representing their

44 respective districts as newly described under this Act.

45 SECTION 3.

46 All laws and parts of laws in conflict with this Act are repealed.
