

House Bill 1341 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act providing for the election of members of the Board of Education of Pike
2 County, approved April 18, 1967 (Ga. L. 1967, p. 3152), as amended, particularly by an Act
3 approved February 27, 2012 (Ga. L. 2012, p. 3793), so as to change the description of the
4 education districts; to provide for definitions and inclusions; to provide for the continuation
5 in office of current members; to provide for related matters; to provide for effective dates;
6 to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act providing for the election of members of the Board of Education of Pike County,
10 approved April 18, 1967 (Ga. L. 1967, p. 3152), as amended, particularly by an Act approved
11 February 27, 2012 (Ga. L. 2012, p. 3793), is amended by revising Section 1 as follows:

12 "SECTION 1.

13 (a) Those members of the Board of Education of Pike County who are serving as such on
14 the effective date of this section and any person selected to fill a vacancy in any such office
15 shall continue to serve as such members until the regular expiration of their respective

16 terms of office and upon the election and qualification of their respective successors. On
17 and after the effective date of this section, the Board of Education of Pike County shall
18 consist of six members, all of whom shall be elected from education districts described in
19 subsection (b) of this section.

20 (b) For purposes of electing members of the board of education, the Pike County School
21 District is divided into six education districts. One member of the board shall be elected
22 from each such district. The six education districts shall be and correspond to those six
23 numbered districts described in Appendix A attached to and made a part of this Act and
24 further identified as 'User: Pike SB Plan Name: PikeSB-2022 Plan Type: Local'.

25 (c)(1) For the purposes of such plan:

26 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
27 provided in the report of the Bureau of the Census for the United States decennial
28 census of 2020 for the State of Georgia. The separate numeric designations in a district
29 description which are underneath a VTD heading shall mean and describe individual
30 Blocks within a VTD as provided in the report of the Bureau of the Census for the
31 United States decennial census of 2020 for the State of Georgia; and

32 (B) Except as otherwise provided in the description of any district, whenever the
33 description of any district refers to a named city, it shall mean the geographical
34 boundaries of that city as shown on the census maps for the United States decennial
35 census of 2020 for the State of Georgia.

36 (2) Any part of the Pike County School District which is not included in any district
37 described in subsection (b) of this section shall be included within that district contiguous
38 to such part which contains the least population according to the United States decennial
39 census of 2020 for the State of Georgia.

40 (3) Any part of the Pike County School District which is described in subsection (b) of
41 this section as being included in a particular district shall nevertheless not be included
42 within such district if such part is not contiguous to such district. Such noncontiguous

43 part shall instead be included within that district contiguous to such part which contains
44 the least population according to the United States decennial census of 2020 for the State
45 of Georgia.

46 (d) Education Districts 1 through 6, as they exist immediately prior to the effective date
47 of this section, shall continue to be designated as Education Districts 1 through 6,
48 respectively, but as newly described under this section, and on and after the effective date
49 of this section, such members of the board serving from those former education districts
50 shall be deemed to be serving from and representing their respective districts as newly
51 described under this section."

52 **SECTION 2.**

53 Said Act is further amended by striking in its entirety the attachment thereto containing the
54 descriptions of the six education districts which is identified as 'Plan: pikesb-2012 Plan
55 Type: Local Administrator: Pike User: Gina'.

56 **SECTION 3.**

57 The provisions of this Act necessary to conduct elections for the members of the board
58 in 2022 shall become effective upon the approval of this Act by the Governor or upon its
59 becoming law without such approval. The remaining provisions of this Act shall become
60 effective on January 1, 2023.

61 **SECTION 4.**

62 All laws and parts of laws in conflict with this Act are repealed.
