

House Bill 1465 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act providing for the election of the members of the Board of Education of  
2 Mitchell County, approved March 4, 1970 (Ga. L. 1970, p. 2239), as amended, so as to  
3 change the education districts; to provide for definitions and inclusions; to provide for the  
4 continuation in office for current members; to provide an effective date; to provide for related  
5 matters; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act providing for the election of the members of the Board of Education of Mitchell  
9 County, approved March 4, 1970 (Ga. L. 1970, p. 2239), as amended, is amended by revising  
10 subsections (b) and (c) of Section 2 as follows:

11 "(b) For purposes of electing members of the board of education, the Mitchell County  
12 School District is divided into seven education districts. One member of the board shall  
13 be elected from each such district. Education Districts 1 through 6 shall be and correspond  
14 to those six numbered districts described in Appendix A attached to and made a part of this  
15 Act and further identified as 'User: Mitchell SB Plan Name: MitchellSB-2022 Plan Type:

16 Local'. Education District 7 shall be an at-large district and shall consist of all of the  
17 Mitchell County School District.

18 (c)(1) For the purposes of such plan:

19 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
20 provided in the report of the Bureau of the Census for the United States decennial  
21 census of 2020 for the State of Georgia. The separate numeric designations in a district  
22 description which are underneath a VTD heading shall mean and describe individual  
23 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
24 United States decennial census of 2020 for the State of Georgia; and

25 (B) Except as otherwise provided in the description of any district, whenever the  
26 description of any district refers to a named city, it shall mean the geographical  
27 boundaries of that city as shown on the census maps for the United States decennial  
28 census of 2020 for the State of Georgia.

29 (2) Any part of the Mitchell County School District which is not included in any district  
30 described in subsection (b) of this section shall be included within that district contiguous  
31 to such part which contains the least population according to the United States decennial  
32 census of 2020 for the State of Georgia.

33 (3) Any part of the Mitchell County School District which is described in subsection (b)  
34 of this section as being included in a particular district shall nevertheless not be included  
35 within such district if such part is not contiguous to such district. Such noncontiguous  
36 part shall instead be included within that district contiguous to such part which contains  
37 the least population according to the United States decennial census of 2020 for the State  
38 of Georgia."

## SECTION 2.

40 (a) Those members of the Board of Education of Mitchell County who are serving as such  
41 on the effective date of this Act and any person selected to fill a vacancy in any such office

42 shall continue to serve as such members until the regular expiration of their respective terms  
43 of office and upon the election and qualification of their respective successors.

44 (b) Education Districts 1, 2, 3, 4, 5, and 6, as they exist immediately prior to the effective  
45 date of this Act, shall continue to be designated as Education Districts 1, 2, 3, 4, 5, and 6,  
46 respectively, but as newly described under this Act, and on and after the effective date of this  
47 Act, such members of the board serving from those former education districts shall be  
48 deemed to be serving from and representing their respective districts as newly described  
49 under this Act.

50 **SECTION 3.**

51 This Act shall become effective on January 1, 2023.

52 **SECTION 4.**

53 All laws and parts of laws in conflict with this Act are repealed.
