

House Bill 1471 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act to divide the County of Stephens into school districts, approved  
2 March 23, 1977 (Ga. L. 1977, p. 3875), as amended, so as to revise the districts for the  
3 election of members of the board of education; to provide for definitions and inclusions; to  
4 provide for manner of election; to provide for continuation in office of current members; to  
5 provide for related matters; to provide effective dates; to repeal conflicting laws; and for  
6 other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act to divide the County of Stephens into school districts, approved March 23, 1977  
10 (Ga. L. 1977, p. 3875), as amended, is amended by revising subsection (a) of Section (2) as  
11 follows:

12 "(a)(1) For the purpose of electing members of the board of education, the Stephens  
13 County School District shall be divided into three education districts. Education  
14 Districts 1, 2, and 3 shall be and correspond to those three numbered districts described  
15 in Appendix A attached to and made a part of this Act and further identified as 'User:  
16 Stephens SB Plan Name: StephensSB-2022 Plan Type: Local'.

17 (2) For the purposes of such plan:

18 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
19 provided in the report of the Bureau of the Census for the United States decennial  
20 census of 2020 for the State of Georgia. The separate numeric designations in a district  
21 description which are underneath a VTD heading shall mean and describe individual  
22 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
23 United States decennial census of 2020 for the State of Georgia; and

24 (B) Except as otherwise provided in the description of any district, whenever the  
25 description of any district refers to a named city, it shall mean the geographical  
26 boundaries of that city as shown on the census maps for the United States decennial  
27 census of 2020 for the State of Georgia.

28 (3) Any part of the Stephens County School District which is not included in any district  
29 described in paragraph (1) of this subsection shall be included within that district  
30 contiguous to such part which contains the least population according to the United States  
31 decennial census of 2020 for the State of Georgia.

32 (4) Any part of the Stephens County School District which is described in paragraph (1)  
33 of this subsection as being included in a particular district shall nevertheless not be  
34 included within such district if such part is not contiguous to such district. Such  
35 noncontiguous part shall instead be included within that district contiguous to such part  
36 which contains the least population according to the United States decennial census  
37 of 2020 for the State of Georgia."

38 **SECTION 2.**

39 (a) Those members of the Board of Education of Stephens County who are serving as such  
40 on the effective date of this Act and any person selected to fill a vacancy in any such office  
41 shall continue to serve as such members until the regular expiration of their respective terms  
42 of office and upon the election and qualification of their respective successors.

43 (b) Education Districts 1, 2, and 3, as they exist immediately prior to the effective date of  
44 this Act, shall continue to be designated as Education Districts 1, 2, and 3, respectively, but  
45 as newly described under this Act, and on and after the effective date of this Act, such  
46 members of the board serving from those former education districts shall be deemed to be  
47 serving from their respective districts as newly described under this Act.

48 **SECTION 3.**

49 The provisions of this Act necessary to conduct elections for the members of the Board of  
50 Education of Stephens County in 2022 shall become effective upon the approval of this Act  
51 by the Governor or upon its becoming law without such approval. The remaining provisions  
52 of this Act shall become effective on January 1, 2023.

53 **SECTION 4.**

54 All laws and parts of laws in conflict with this Act are repealed.
