A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act to provide for the election of members to the Dade County board of

- 3 an Act approved April 7, 2004 (Ga. L. 2004, p. 3530), so as to change the description of the
- 4 education districts; to provide for definitions and inclusions; to provide for compensation of
- 5 the board; to provide for the continuation in office of current members; to provide for related
- 6 matters; to provide an effective date; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act to provide for the election of members to the Dade County board of education,
- approved February 6, 1984 (Ga. L. 1984, p. 3575), as amended, particularly by an Act
- approved April 7, 2004 (Ga. L. 2004, p. 3530), is amended by revising Section 1 as follows:
- 12 "SECTION 1.
- 13 (a) The board of education of Dade County shall be composed of five members to be
- elected as provided in this Act. For the purpose of electing members of the board of
- education, Dade County shall be divided into five education districts. Education Districts 1

16 through 4 shall be and correspond to those four numbered districts described in

- 17 Appendix A attached to and made a part of this Act and further identified as 'User:
- Dade Co. Plan Name: DadeCCSB-2022 Plan Type: Local'. Education District 5 shall be
- 19 composed of the entire Dade County school district.
- 20 (b)(1) For the purposes of such plan:
- 21 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial
- census of 2020 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- 25 Blocks within a VTD as provided in the report of the Bureau of the Census for the
- 26 United States decennial census of 2020 for the State of Georgia; and
- 27 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical
- boundaries of that city as shown on the census maps for the United States decennial
- census of 2020 for the State of Georgia.
- 31 (2) Any part of the Dade County School District which is not included in any district
- described in subsection (a) of this section shall be included within that district contiguous
- to such part which contains the least population according to the United States decennial
- census of 2020 for the State of Georgia.
- 35 (3) Any part of the Dade County School District which is described in subsection (a) of
- 36 this section as being included in a particular district shall nevertheless not be included
- within such district if such part is not contiguous to such district. Such noncontiguous
- part shall instead be included within that district contiguous to such part which contains
- 39 the least population according to the United States decennial census of 2020 for the State
- 40 of Georgia."

41 SECTION 2.

42 Said Act is further amended by repealing subsection (e) of Section 4.

43 SECTION 3.

- 44 (a) Those members of the Board of Education of Dade County who are serving as such on
- 45 the effective date of this Act and any person selected to fill a vacancy in any such office shall
- 46 continue to serve as such members until the regular expiration of their respective terms of
- 47 office and upon the election and qualification of their respective successors.
- 48 (b) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act,
- 49 shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly
- described under this Act, and on and after the effective date of this Act, such members of the
- 51 board serving from those former districts shall be deemed to be serving from and
- 52 representing their respective districts as newly described under this Act.
- SECTION 4.
- 54 This Act shall become effective on January 1, 2023.
- 55 SECTION 5.
- All laws and parts of laws in conflict with this Act are repealed.
