

House Bill 877 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED

AN ACT

1 To amend an Act re-creating and establishing a Board of Commissioners of Barrow County,  
 2 approved April 2, 1976 (Ga. L. 1976, p. 4033), as amended, particularly by an Act approved  
 3 September 7, 2011 (Ga. L. 2011 Ex. Sess., p. 265), so as to change the composition of the  
 4 election districts from which the members of the Board of Commissioners of Barrow County  
 5 are elected; to define certain terms; to provide for continuation in office of persons serving  
 6 as members of the board on a certain date; to provide for related matters; to repeal conflicting  
 7 laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 An Act re-creating and establishing a Board of Commissioners of Barrow County, approved  
 11 April 2, 1976 (Ga. L. 1976, p. 4033), as amended, particularly by an Act approved September  
 12 7, 2011 (Ga. L. 2011 Ex. Sess., p. 265), is amended by revising Section 4 as follows:

13 "SECTION 4.

14 (a) For the purposes of electing the members of the board other than the chairperson,  
 15 Barrow County shall be divided into six commissioner districts. The six commissioner

16 districts shall be and correspond to those six numbered districts described in Appendix A  
17 attached to and made a part of this Act and further identified as 'User: Barrow Plan Name:  
18 barrowccsb-2022 Plan Type: Local'.

19 (b)(1) For the purposes of such plan:

20 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
21 provided in the report of the Bureau of the Census for the United States decennial  
22 census of 2020 for the State of Georgia. The separate numeric designations in a district  
23 description which are underneath a VTD heading shall mean and describe individual  
24 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
25 United States decennial census of 2020 for the State of Georgia; and

26 (B) Except as otherwise provided in the description of any district, whenever the  
27 description of any district refers to a named city, it shall mean the geographical  
28 boundaries of that city as shown on the census maps for the United States decennial  
29 census of 2020 for the State of Georgia.

30 (2) Any part of Barrow County which is not included in any district described in  
31 subsection (a) of this section shall be included within that district contiguous to such part  
32 which contains the least population according to the United States decennial census  
33 of 2020 for the State of Georgia.

34 (3) Any part of Barrow County which is described in subsection (a) of this section as  
35 being included in a particular district shall nevertheless not be included within such  
36 district if such part is not contiguous to such district. Such noncontiguous part shall  
37 instead be included within that district contiguous to such part which contains the least  
38 population according to the United States decennial census of 2020 for the State of  
39 Georgia."

40 **SECTION 2.**

41 Said Act is further amended by revising Section 5 as follows:

42 "SECTION 5.

43 (a) The members of the board serving in office on the effective date of this Act, and any  
44 person selected to fill a vacancy in any such office shall continue to serve until the  
45 expiration of the terms for which they were elected and until their successors are elected  
46 and qualified.

47 (b)(1) All members of the board shall be elected from the commissioner districts  
48 described in Section 4 of this Act.

49 (2) The members of the board representing Commissioner Districts 4, 5, and 6 shall be  
50 elected at the general election in 2022 and quadrennially thereafter and shall take office  
51 on the first day of January immediately following their election for terms of four years  
52 and until their successors are elected and qualified.

53 (3) The chairperson and members of the board representing Commissioner Districts 1, 2,  
54 and 3 shall be elected at the general election in 2024 and quadrennially thereafter and  
55 shall take office on the first day of January immediately following their election for terms  
56 of four years and until their successors are elected and qualified."

57 **SECTION 3.**

58 Said Act is further amended by striking in its entirety the attachment thereto containing the  
59 descriptions of commissioner districts which is identified as Plan: barrowccsb-2011 Plan  
60 Type: Local User: admin.

61 **SECTION 4.**

62 Commissioner Districts 1, 2, 3, 4, 5, and 6 as they exist immediately prior to the effective  
63 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, 4, 5, and  
64 6 respectively, but as newly described under this Act, and on and after the effective date of  
65 this Act, such members of the board serving from those former commissioner districts shall

66 be deemed to be serving from and representing their respective districts as newly described  
67 under this Act.

68 **SECTION 5.**

69 All laws and parts of laws in conflict with this Act are repealed.
