A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating a Board of Commissioners of Walton County, approved
- 2 August 1, 1929 (Ga. L. 1929, p. 747), as amended, particularly by an Act approved
- 3 March 5, 2012 (Ga. L. 2012, p. 3920), so as to change the description of the commissioner
- 4 districts; to provide for definitions and inclusions; to provide for qualifications of members;
- 5 to provide for continuation in office of current members; to provide for election and terms
- 6 of office of subsequent members; to provide for effective dates; to repeal conflicting laws;
- 7 and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 SECTION 1.

- 10 An Act creating a Board of Commissioners of Walton County, approved August 1, 1929
- 11 (Ga. L. 1929, p. 747), as amended, particularly by an Act approved March 5, 2012
- 12 (Ga. L. 2012, p. 3920), is amended by revising Section 2 as follows:
- 13 "SECTION 2.
- 14 (a) Those members of the Board of Commissioners of Walton County who are serving as
- such on the effective date of this Act, and any person selected to fill a vacancy in any such

office, shall continue to serve as such members until the regular expiration of their respective terms of office and upon the election and qualification of their respective successors. On and after the effective date of this Act, the Board of Commissioners of Walton County shall consist of seven members, six of whom shall be elected from commissioner districts described in subsection (b) of this section and a chairperson who

- 21 is elected at large as provided in this Act.
- 22 (b) For purposes of electing members of the board of commissioners, other than the 23 chairperson, Walton County shall be divided into six commissioner districts. One member 24 of the board shall be elected from each such district. The six commissioner districts shall 25 be and correspond to those six numbered districts described in and attached to and made 26 a part of this Act and further identified as 'User: Walton CC Plan Name: Walton CC-2022
- 27 Plan Type: Local'.

- 28 (c)(1) For the purposes of such plan:
 - (A) The term 'VTD' shall mean and describe the same geographical boundaries as provided in the report of the Bureau of the Census for the United States decennial census of 2020 for the State of Georgia. The separate numeric designations in a district description which are underneath a VTD heading shall mean and describe individual Blocks within a VTD as provided in the report of the Bureau of the Census for the United States decennial census of 2020 for the State of Georgia; and
 - (B) Except as otherwise provided in the description of any district, whenever the description of any district refers to a named city, it shall mean the geographical boundaries of that city as shown on the census maps for the United States decennial census of 2020 for the State of Georgia.
 - (2) Any part of Walton County which is not included in any such district described in that attachment shall be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia.

(3) Any part of Walton County which is described in subsection (b) of this section as being included in a particular district shall nevertheless not be included within such district if such part is not contiguous to such district. Such noncontiguous part shall instead be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2020 for the State of Georgia. Except as otherwise provided in the description of any commissioner district, whenever the description of such district refers to a named city, it shall mean the geographical boundaries of that city as shown on the census map for the United States decennial census of 2020 for the State of Georgia.

- (d) No person shall be a member of the board if that person is ineligible for such office pursuant to Code Section 45-2-1 of the O.C.G.A. or any other general law applicable to that office.
- 55 (e) In order to be elected as a member of the board from a commissioner district, a person 56 must be a resident of that commissioner district and must receive the number of votes cast 57 as required by general law for that office in that district only. Only electors who are residents of that commissioner district may vote for a member of the board for that district. 58 59 At the time of qualifying for election as a member of the board from a commissioner 60 district, each candidate for such office shall specify the commissioner district for which 61 that person is a candidate. A person elected or appointed as a member of the board from a commissioner district must continue to reside in that district during that person's term of 62 63 office or that office shall become vacant.
- 64 (f) The chairperson of the board may reside anywhere within Walton County and, if 65 elected, must receive the number of votes cast for that office as required by general law in 66 the entire county. The chairperson must continue to reside within the county during that 67 person's term of office or that office shall become vacant.
- 68 (g) All future successors to the chairperson and the members of the board whose terms of 69 office are to expire shall be elected at the time of the state-wide general election

70 immediately preceding the expiration of such terms, shall take office the first day of

- January immediately following that election, and shall serve for terms of office of four
- years each. The chairperson and the members of the board shall serve for their terms of
- office and until their respective successors are elected and qualified.
- 74 (h) The chairperson and all members of the board who are elected thereto shall be
- nominated and elected in accordance with Chapter 2 of Title 21 of the O.C.G.A., the
- 76 'Georgia Election Code.'
- 77 (i) Commissioner Districts 1, 2, 3, 4, 5, and 6, as they exist immediately prior to the
- 78 effective date of this Act, shall continue to be designated as Commissioner
- 79 Districts 1, 2, 3, 4, 5, and 6, respectively, but as newly described under this Act, and on and
- after the effective date of this Act, such members of the board serving from those former
- commissioner districts shall be deemed to be serving from and representing their respective
- districts as newly described under this Act."

83 SECTION 2.

- 84 The provisions of this Act necessary to conduct elections for the members of the Board of
- 85 Commissioners of Walton County in 2022 shall become effective upon the approval of this
- 86 Act by the Governor or upon its becoming law without such approval. The remaining
- 87 provisions of this Act shall become effective on January 1, 2023.

88 SECTION 3.

89 All laws and parts of laws in conflict with this Act are repealed.
