

House Bill 946 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act providing for the election of the members of the Board of Education of
2 Butts County, approved March 30, 1987 (Ga. L. 1987, p. 4919), as amended, particularly by
3 an Act approved September 21, 2011 (Ga. L. 2011 Ex. Sess., p. 386), so as to revise the
4 districts for the election of members of the board of education; to provide for definitions and
5 inclusions; to provide for continuation in office of current members; to provide for effective
6 dates; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act providing for the election of the members of the Board of Education of Butts County,
10 approved March 30, 1987 (Ga. L. 1987, p. 4919), as amended, particularly by an Act
11 approved September 21, 2011 (Ga. L. 2011 Ex. Sess., p. 386), is amended by revising
12 subsections (c) and (d) of Section 1 as follows:

13 "(c) For the purpose of electing members of the board of education, the Butts County
14 School District shall be divided into five education districts. One member of the board
15 shall be elected from each such district. Education Districts 1 through 5 shall be and
16 correspond to those five numbered districts described in Appendix A attached to and made

17 a part of this Act and further identified as 'User: Butts Co. Plan Name: ButtsCCSB-2022
18 Plan Type: Local'.

19 (d)(1) For the purposes of such plan:

20 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
21 provided in the report of the Bureau of the Census for the United States decennial
22 census of 2020 for the State of Georgia. The separate numeric designations in a district
23 description which are underneath a VTD heading shall mean and describe individual
24 Blocks within a VTD as provided in the report of the Bureau of the Census for the
25 United States decennial census of 2020 for the State of Georgia; and

26 (B) Except as otherwise provided in the description of any district, whenever the
27 description of any district refers to a named city, it shall mean the geographical
28 boundaries of that city as shown on the census maps for the United States decennial
29 census of 2020 for the State of Georgia.

30 (2) Any part of the Butts County School District which is not included in any district
31 described in subsection (c) of this section shall be included within that district contiguous
32 to such part which contains the least population according to the United States decennial
33 census of 2020 for the State of Georgia.

34 (3) Any part of the Butts County School District which is described in subsection (c) of
35 this section as being in a particular district shall nevertheless not be included within such
36 district if such part is not contiguous to such district. Such noncontiguous part shall
37 instead be included within that district contiguous to such part which contains the least
38 population according to the United States decennial census of 2020 for the State of
39 Georgia."

40

SECTION 2.

41 (a) Those members of the Board of Education of Butts County who are serving as such on
42 the effective date of this Act and any person selected to fill a vacancy in any such office shall

43 continue to serve as such members until the regular expiration of their respective terms of
44 office and upon the election and qualification of their respective successors.

45 (b) Education Districts 1 through 5, as they exist immediately prior to the effective date of
46 this Act, shall continue to be designated as Education Districts 1 through 5, respectively, but
47 as newly described under this Act, and on and after the effective date of this Act, such
48 members of the board serving from those former districts shall be deemed to be serving from
49 and representing their respective districts as newly described under this Act.

50 **SECTION 3.**

51 The provisions of this Act necessary to conduct elections for the members of the board in
52 2022 shall become effective upon the approval of this Act by the Governor or upon its
53 becoming law without such approval. The remaining provisions of this Act shall become
54 effective January 1, 2023.

55 **SECTION 4.**

56 All laws and parts of laws in conflict with this Act are repealed.
